

General remarks and official action taken:

This is a default order taken against Nicholas Trevino (Respondent) because he misappropriated, converted to his own use, or illegally withheld money belonging to an insurer, engaged in fraudulent or dishonest practices, is not actively engaged in soliciting or writing insurance for the public generally, and failed to notify the department of a change in his mailing address and email address. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

1. On October 24, 2023, the department filed a Notice of Hearing, attached as Exhibit A, together with a previously filed Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.

2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
3. The department sent the Notice of Hearing and Original Petition together to Respondent's last known address provided in writing to the department, [REDACTED] [REDACTED] San Antonio, Texas 78245. The Notice of Hearing and Original Petition were also sent by electronic mail.
4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.201, and 4054.051; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
3. The department provided proper notice of the hearing under TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.89.



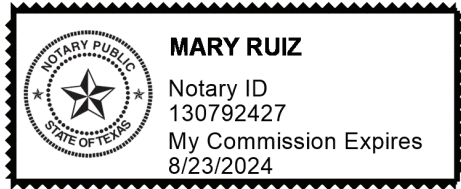

NOTICE OF HEARING

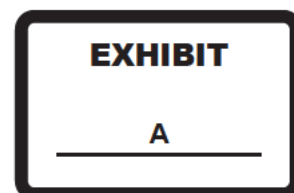
The Texas Department of Insurance (TDI) seeks to take disciplinary action against you. This Notice of Hearing and the Original Petition, which is attached and incorporated for all purposes, states the allegations against you and the relief sought by TDI.

A public hearing will be held before an Administrative Law Judge on **Monday, January 29, 2024, at 9:00 AM CT**. The hearing will take place via videoconference using a videoconference platform controlled by the State Office of Administrative Hearings, unless otherwise ordered to proceed in another manner by the Administrative Law Judge.

The hearing shall be conducted under TEX. GOV'T CODE, ch. 2001 and 1 TEX. ADMIN. CODE, ch. 155. Unless otherwise directed by the Administrative Law Judge, the hearing shall continue from day to day in the offices of the State Office of Administrative Hearings until concluded. You have the right to appear at this hearing and to be represented by an attorney.

ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to take disciplinary action against Nicholas Trevino. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

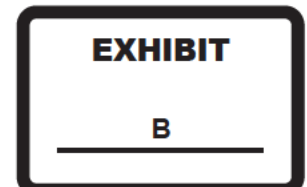
The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.201, and 4054.051; and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

Licensure

1. Nicholas Trevino (Trevino), individual identification no. 2500621, has held a county mutual agent license with the TDI since June 22, 2022. Trevino held a temporary county mutual license from January 27, 2022, until June 22, 2022.
2. In addition, Trevino has held a general lines agent license with a life, accident, health, and HMO qualification with TDI since July 1, 2022, and held a temporary license with the same qualification from January 26, 2022, until July 1, 2022.

Misappropriation

3. According to TDI's records, Trevino was appointed by The Reliable Life Insurance Company (Reliable Life) effective January 26, 2022, while holding his temporary life, accident, health, and HMO license.
4. While holding his general lines license, Trevino's appointment was canceled by Reliable Life on December 30, 2022, for abandoning his position.
5. Following Trevino's termination, Reliable Life performed a routine audit comparing what customers tendered to Trevino to what Trevino reported in receivables to Reliable Life.
6. Reliable Life found that Trevino failed to report and remit \$2,442.23 to Reliable Life which he collected from Reliable Life's policyholders.
7. Trevino's cash bond in the amount of \$369.40 was applied to the deficiency leaving a balance of \$2,072.83 due to Reliable Life.
8. Reliable Life attempted to collect the balance from Trevino without success.
9. According to TDI's records, Reliable Life canceled Trevino's appointment for cause, effective January 3, 2023.

Not Actively Engaged in the Business of Insurance

10. According to TDI's records, Trevino also held an appointment with Capitol County Mutual Fire Insurance Company from January 27, 2022 until January 3, 2023, when that appointment was also canceled for cause by Kemper, the parent company of Reliable Life.
11. Trevino currently has no active appointments and has not been actively engaged in soliciting or writing insurance for the public generally for nearly 10 months.

Failure to Update Email and Mailing Addresses

12. TDI staff confirmed in April 2023 that Trevino's designated email address with a Kemper domain name, as shown in TDI's records, did not belong to Trevino. Instead, it belonged to a Reliable Life employee, specifically Trevino's former supervisor. Trevino did not update his email address with TDI after he was terminated from Reliable Life.
13. In July 2023, Reliable Life provided TDI with Trevino's personal email address, according to their records.
14. On July 11, 2023, TDI sent Trevino a reasonable request for information pursuant to TEX. INS. CODE § 38.001, to the personal email address Reliable Life had for Trevino, which was provided to TDI.
15. Trevino did not respond to the July 11, 2023, inquiry.
16. On July 31, 2023, TDI sent the July 11, 2023 request for information, together with a cover letter, by certified mail to Trevino at the mailing address he had designated in TDI's records. This correspondence was returned to TDI as undeliverable.
17. Trevino failed to notify TDI of a change to his mailing address.

Legal Allegations

1. Trevino has committed acts for which a license holder may be disciplined under TEX. INS. CODE §§ 4005.101 and 4005.102, because Trevino:
 - a. misappropriated, converted to his own use, or illegally withheld money belonging to an insurer, insured, enrollee, or beneficiary, in violation of TEX. INS. CODE § 4005.101(b)(4).
 - b. engaged in fraudulent or dishonest practices, in violation of TEX. INS. CODE § 4005.101(b)(5).

- c. Is not actively engaged in soliciting or writing insurance for the public generally as required by TEX. INS. CODE § 4001.104(a), and in violation of TEX. INS. CODE § 4005.101(b)(10).
2. Trevino failed to notify TDI of a change of his mailing address, in violation of TEX. INS. CODE § 4001.252(a)(1) and 28 TEX. ADMIN. CODE § 19.906.
3. Trevino failed to notify TDI that communications could no longer be received at his designated email address in TDI's records, and he failed to notify TDI of a new email address for receipt of official department communications within 10 business days, in violation of 28 TEX. ADMIN. CODE § 1.1302(c)

Relief Sought

If one or more of the above allegations is found to be true, TDI asks the Administrative Law Judge to enter a Proposal for Decision recommending that the commissioner of insurance issue an order:

1. revoking Trevino's licenses; and,
2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.

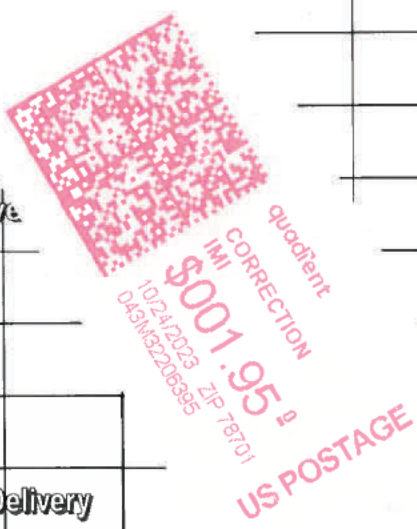

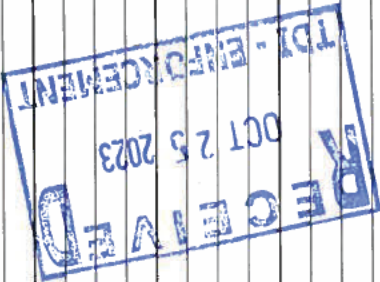
