Once submitted, the reinstatement will be reviewed by the state and if complete you will be emailed a copy of the license with the new expiration date. If the reinstatement has deficiencies, you will be notified by email. If the deficiency requires an attachment to your reinstatement, reference our tutorial on "Attaching a Deficiency to a Renewal".
