As a professor in *Global Conflict Resolution* at the University of St. Thomas, she teaches future foreign service officers. In 2019, Melissa was honored to serve as the President of the Texas Association of Mediators and endeavors to further the field of ADR for young and new dispute resolution professionals.

Melissa earned the distinction as Rising Star Honoree selected by *Super Lawyers* in 2020-2021 as a top rated Alternative Dispute Resolution attorney in Texas. As a Texas Credentialed Distinguished Mediator, Melissa has mediated hundreds of cases. Additionally, she serves as an arbitrator for surprise-billing across the country. Since 2013, when Melissa was awarded a federal contract to practice as a mediator for the Equal Employment Opportunity Commission (EEOC), she has settled numerous employment discrimination cases. She also sits on the panel of mediators for various District and County Court judges in the greater Houston area. Moreover, since 2012 Melissa has practiced as an Auto-Line arbitrator for the Better Business Bureau (BBB) for consumer disputes arising under the Texas Lemon Laws.

Melissa graduated with high honors from Rice University, double majoring in Sports Medicine and Hispanic Studies. Her law degree is from Southern Methodist University (SMU) School of Law. While in law school, Melissa wrote for the prestigious SMU *International Law Review*.
