Roberto M. Garcia has been engaged in the private practice of law in the Rio Grande Valley of Texas since his return from law school in 1976.

Mr. Garcia has served as General Counsel for various Rio Grande Valley public entities such as Valley View ISD, La Villa ISD, Donna ISD, Edinburg CISD, Hidalgo County Housing Authority, Edinburg Housing Authority, Hidalgo County Fire Districts 2 and 3, City of Donna, City of La Villa and the City of Progreso. Mr. Garcia also served as an elected member of the Board of Trustees of the McAllen ISD.

As General Counsel to the various public entities, Mr. Garcia performed complex executive and professional level work as legal advisor to the City Commissions, Boards of Education, Housing Authority Boards, their chief executives such as City Manager, School Superintendent and Executive Director, as well as to their committees and department heads. Mr. Garcia's duties included, but were not limited to rendering oral and written legal opinions, preparing legal documents such as contracts, resolutions and ordinances, researching, interpreting and applying laws, court decisions, and other legal authority to the operations of the entities, representing the entities in lawsuits and administrative hearings and attending meetings and rendering legal advice on matters on the agenda.

Mr. Garcia has represented public sector labor unions and employees in all forums including arbitration tribunals, Equal Employment Opportunity Commission (EEOC) and Merit Systems Protection Board (MSPB) as well as in state and federal courts. Mr. Garcia has been involved in arbitrations and hearings as an employee advocate concerning issues such as absence/leave, alcohol/drug abuse, classification. demotion. discharge/discipline, discrimination. bonuses. grievances, hiring, pay, layoff, management rights and past practice.

Mr. Garcia also has extensive experience as an employee advocate in handling Internal Investigations, Critical Incident Responses, Officer Involved Shootings, Death in Custody Matters, Federal Suspension and Removal Proceedings, Disciplinary Appeals, Arbitrations, Grievances and EEOC and MSPB matters. Mr. Garcia also represents Federal Officers/Agents in Department of Justice Civil Rights Investigations, Federal Grand Jury Civil Rights Investigations as well as investigations before the Federal Bureau of Investigation (FBI), Department of Homeland Security Office of Inspector General (DHS/OIG), Immigration and Customs Enforcement Office of Professional Responsibility (ICE/OPR), Department of Homeland Security Customs and Border Protection Office of Internal Affairs (DHS/CBP/IA). He also represents Municipal Police Officers, County Deputy Sheriffs, County Deputy Constables and Department of Public Safety (DPS) Troopers before their respective Office of Professional Responsibility, Disciplinary Review Boards, Shooting Review Boards, Civil Service Commissions and Independent Hearing Examiners.

In the area of Alternative Dispute Resolution (ADR) Mr. Garcia has been trained and qualified by the American Arbitration Association (AAA) as a Mediator. He has also been trained and qualified as a Family Law, and as a Child Protective Services Mediator by Mediators & Arbitrators of America. Based upon his training and experience, he holds a Credentialed Advanced Mediator designation conferred by the Texas Mediator Credentialing Association. He has been trained and qualified by the Federal Mediation and Conciliation Service (FMCS) as a Labor Arbitrator. He is trained and qualified through the American Health Lawyers Association (AHLA) in Health Care Arbitration and in Peer Review Hearings. He is also trained and qualified through the AHLA as a Mediator of Health Care Controversies. As a Mediator, Mr. Garcia is a neutral and does not act as a judge or decision-maker but rather works to build, maintain, and improve communication between the disputants. In doing so, he facilitates information to and between the disputants, cultivates a willingness to engage in cooperative negotiation and serves as a neutral reality checker.

As an Independent Hearing Examiner or Arbitrator, Mr. Garcia presides over hearings involving disputed matters. Mr. Garcia directs the proceedings including conducting pre-hearing conferences and motion hearings, establishing discovery procedures, making rulings on issues of procedure, evidence and law, resolving scheduling issues and logistics, maintaining an accurate record, marshaling witnesses and exhibits, ensuring a fair hearing on the merits, reviewing post hearing briefs and making a determination and award.
