National Council on Compensation Insurance Item U-1400

Description:

- The National Council on Compensation Insurance (NCCI) filed Item U-1400 Revisions to
 Statistical Plan for Workers Compensation and Employers Liability Insurance. The primary
 purpose of this item is to implement a newly redesigned Part 6—Coding Values in NCCI's
 Statistical Plan for Workers Compensation and Employers Liability Insurance (Statistical Plan).
 Additionally, this item includes several reporting clarifications and maintenance items to
 improve the usability of reporting rules in NCCI's Statistical Plan.
- This item proposes that NCCI's Statistical Plan be changed, approved, and implemented
 effective January 1, 2018, for new and renewal businesses. For Texas, the item includes the
 following proposals:
 - Newly redesigned Part 6—Coding Values section
 - Data element organization—All data elements in Part 6 are organized in the following categories:
 - Header/Policy Information, Exposure Information, Loss Information, and Statistical Codes.
 - New table format structure—All data elements and coding values are displayed in separate tables to improve ease of use when searching for and using Statistical Plan coding values.
 - Statistical Plan reporting rule cross-references—New rule cross-references
 added for specific coding values to the associated Statistical Plan reporting rule.
 - Reporting clarifications to improve the usability of reporting rules.
 - Manual maintenance items to include reporting rule cross-reference changes due to the redesign of Part 6.
 - As Part 6 is being replaced in its entirety, Exhibit 25 displays the current Part 6 in strikethrough and Exhibit 26 displays the proposed Part 6 in its entirety without underline (as it would appear published).
 - Exhibits 28, 29, and 30 provide state exhibits as applicable.
