### **Description:**

- The National Council on Compensation Insurance (NCCI) filed *Item R-1414-A Amendment to Item R-1414 Revisions to Retrospective Rating Plan Manual Appendix B and all Related Rules and Endorsements* on June 19, 2018. *Item R-1414-A* is a national filing.
