### Instructions

- **Application fee: \$30.00**
- Print or type your information.
- All fees are nonrefundable, except for overpayments from mistakes of law or fact.
- Send one payment to cover fees. Payments for various applications must be combined.

- Permits cannot be issued to anyone under 18 years of age.

### 5. Signature

In applying for a retail fireworks permit:

- I am familiar and will comply with Chapter 2154, Texas Occupations Code, and the Fireworks Rules.
- I agree I have not or will not purchase fireworks for my retail operation from any person or firm that does not have a valid Texas fireworks distributor or jobber license.
- I am aware that any permit issued to me is not valid until signed by me.
- I hereby authorize the State Fire Marshal, his deputy, or any duly authorized fire prevention officer to enter, examine, and inspect any premises, building, room, or establishment used in connection with this permit to determine compliance with the provisions of Chapter 2154 of the Texas Occupations Code, and the Fireworks Rules.
- By my signature, I verify that the information on the application and its attachments are true.

- I understand that knowingly providing a false answer to any question or submitting false information or documents with this application may be tampering with a governmental record which is punishable under the Texas Penal Code Chapter 37, Section 37.10.
