FINAL ACCOUNTING AND APPLICATION TO CLOSE RECEIVERSHIP AND DISCHARGE RECEIVER AND SPECIAL DEPUTY RECEIVER

TO THE HONORABLE JUDGE OF THIS COURT:

Comes now Angenend & Augustine, P.C., Special Deputy Receiver of First American Life Insurance Company ("First American,") and files this *Final Accounting and Application to Close Receivership and Discharge Receiver and Special Deputy Receiver ("Final Accounting Application,")* and in support respectfully shows the Court as follows:

I. AUTHORITY, BACKGROUND, AND EVIDENCE

1.1 Pursuant to commencement of delinquency proceedings under the Insurer Receivership Act, TEX. INS. CODE ANN. Chapter 443¹ ("Code"), First American was placed in receivership by this Court's *Order Appointing Liquidator and Permanent Injunction* (*"Liquidation Order"*) on February 18, 2010. The *Liquidation Order* appointed the Commissioner of Insurance of the State of Texas as Receiver of First American Life Insurance Company ("Receiver,") and the Receiver filed a *Notice of Designation of Special Deputy Receiver* in this matter designating Angenend & Augustine, P.C. as Special Deputy Receiver of

First American Life Insurance Company ("Special Deputy Receiver") pursuant to TEX INS. CODE ANN. § 443.151(a).

1.2 The Special Deputy Receiver is authorized to file this *Final Accounting Application* pursuant to the Code. Pursuant to TEX. INS. CODE ANN. § 443.154(a), the Special Deputy Receiver has all the powers of the Receiver, unless specifically limited by the Receiver, including the authority to file an application to terminate the liquidation proceeding pursuant to TEX. INS. CODE ANN. § 443.352. The Special Deputy Receiver requests this Court find that the Special Deputy Receiver is authorized to file this *Final Accounting Application* pursuant to TEX. INS. CODE ANN. § 443.154(a) and 443.352.

1.3 Jurisdiction for all matters regarding the receivership estate is properly in the 200th Judicial District Court of Travis County, Texas, as the court in which these delinquency proceedings are pending. TEX. INS. CODE ANN. § 443.005(c).

1.4 The subject matter of this *Final Accounting Application* has been referred to the receivership master appointed in this proceeding in accordance with Paragraph III, Sections 30 and 32, of the *Order of Reference to Master ("Order of Reference")* entered on March 9, 2010. The receivership master appointed under the *Order of Reference* has authority to request and accept evidence in a hearing by submission to support the *Final Accounting Application*. The Special Deputy Receiver requests this Court give the receivership master authority to request and accept evidence in a hearing by submission to support the *Final Accounting Application*.

1.5 This Court approved an *Order Approving Final Report, Approving Final Distribution and Dissolving Charter ("Distribution Order")* on November 1, 2012. The *Distribution Order* required the Special Deputy Receiver to make a distribution of the receivership assets and file a final accounting. 1.6 The Special Deputy Receiver has completed the distribution of assets and submits its final accounting and final statement of expenses as part of this *Final Accounting Application*. The tasks are complete in this estate; therefore, the Special Deputy Receiver requests that the Court approve this *Final Accounting Application* and enter an order terminating this proceeding and discharging both the Receiver and the Special Deputy Receiver.

1.7 Attached as Exhibit A and incorporated by reference as if fully set out is the *Affidavit of Paul D. Angenend*, offered in his capacity as president of Angenend & Augustine, P.C., which serves as evidence of all the factual matters contained in this *Final Accounting Application*. The Special Deputy Receiver requests that this Court admit Exhibit A into evidence.

1.8 Attached as Exhibit B and incorporated by reference as if fully set out is the *Statement of Expenses, Statement of Net Assets, Statement of Net Liabilities, and Sources and Uses of Funds* that reflects First American's financial condition in receivership for this *Final Accounting Application* as of December 10, 2012. The Special Deputy Receiver requests that this Court admit Exhibit B into evidence.

1.9 Attached as Exhibit C and incorporated by reference as if fully set out is the *Sources and Uses of Cash Statement* that lists all funds received and disbursed from the date of receivership for this *Final Accounting Application* through December 10, 2012. The Special Deputy Receiver requests that this Court admit Exhibit C into evidence.

1.10 Attached as Exhibit D and incorporated by reference as if fully set out is the *Disposition of Assets Schedule* that shows all expense transactions for this *Final Accounting Application* from the date of the *Final Report and Application to Make Final Distribution and*

Dissolve Charter. The Special Deputy Receiver requests that this Court admit Exhibit D into evidence.

1.11 All of the records attached to this *Final Accounting Application* are authenticated as admissible in Exhibit A and are true and correct copies of papers, documents, or records that are part of the books, records, documents, and papers of the First American receivership estate. TEX. INS. CODE ANN. § 443.017(b). The Special Deputy Receiver requests that this Court admit the facts contained in the *Final Accounting Application* and its exhibits, testified to and authenticated by Exhibit A, into evidence as *prima facie* proof of the matters asserted. TEX. INS. CODE ANN. § 443.017(c). The Special Deputy Receiver also requests that this Court find that the evidence submitted supports approval of the *Final Accounting Application*.

II. DISTRIBUTION

2.1 In accordance with the *Distribution Order*, the Special Deputy Receiver made a final distribution composed of several parts. First, the Special Deputy Receiver made a distribution from the Texas Treasury account on November 6, 2012, in the amount of \$8,958,481.39 to the Special Deputy Receiver of Lincoln Memorial Life Insurance Company ("LML SDR"). The second prong of the distribution was an assignment of assets in the amount of \$390,658.45 that was transferred to the LML SDR consisting of the value of securities and two proofs of claim filed with the Special Deputy Receiver of Texas Memorial Life Insurance Company ("TML"). The first part of the assigned assets was an account at Pershing. On November 9, 2012, the Special Deputy Receiver transferred the Pershing account in the amount of \$390,657.45, the value of the securities and cash, to the LML SDR. On November 13, 2012, the Special Deputy Receiver assigned the two TML POCs, with a value of \$1. Finally, the operating account, after all expenses were paid, was distributed to the LML SDR on December

10, 2012, in the amount of \$1,891.66. These distributions totaling \$9,351,031.50 to the LML SDR represent a 90% distribution to *Class 5*. The remaining amount of the LML SDR's allowed POC is \$1,085,840.50.

2.2 As there were no other claims, there was no other distribution of assets.

III. UNCLAIMED AND RESIDUAL FUNDS

3.1 There were no unclaimed amounts from the distribution made in accordance with the *Distribution Order*.

3.2 The *Distribution Order* entered by this Court authorized the Special Deputy Receiver to deliver any residual funds to the Commissioner of Insurance of the State of Texas ("Commissioner") in her capacity as Commissioner. As described in Paragraph 4.2, all of First American's remaining funds were distributed; thus, there were no residual funds. The Special Deputy Receiver requests that this Court find there are no residual funds.

IV. FINANCIAL STATEMENTS

4.1 Exhibits B, C, and D are the final financial statements as a part of this *Final Accounting Application* for the First American receivership estate. The Special Deputy Receiver requests that this Court find that the Special Deputy Receiver has completed the distribution of assets and submitted its final accounting statements in Exhibits B and C and final statement of expenses in Exhibit B. The Special Deputy Receiver requests that this Court accept Exhibits B, C, and D as the final accounting of financial reports for the First American receivership estate as part of this *Final Accounting Application*. The Special Deputy Receiver also requests that Exhibit B be accepted as the final statement of expenses for this *Final Accounting Application*. 4.2 The *Distribution Order* approved a reserve of \$58,315.90 for estimated expenses to administer this proceeding through its termination, and required the Special Deputy Receiver to file a final statement of expenses pursuant to TEX. INS. CODE ANN. § 443.015(g). Exhibit D is the Special Deputy Receiver's final statement of expenses for this *Final Accounting Application*. The actual closing expenses were \$40,675.89. As mentioned in 2.1 above and as reflected on Exhibit B, the cash remaining in the operating account after all expenses were paid was distributued to the LML SDR in accordance with TEX. INS. CODE ANN. § 443.304 (c).

V. FEDERAL INCOME TAX RETURNS

5.1 The final tax return for 2012 was filed on December 6, 2012. No taxes are owed or will be owed to the Internal Revenue Service. The Special Deputy Receiver requests that this Court find that the final federal income tax return for this year was filed and no taxes are owed.

VI. RECORDS

6.1 The Special Deputy Receiver has identified and transferred all records required to be maintained in compliance with the Approved Records Retention Schedule ("Schedule") to the Commissioner. In accordance with the *Order Granting Authority to Destroy Non-Essential Insurer Records* and the *Distribution Order* entered by this Court, the Special Deputy Receiver was authorized to destroy certain records that were deemed unnecessary or that were permitted to be destroyed after closing the estate and has done so.

6.2 The Special Deputy Receiver has inventoried the remaining insurer and receivership records and transferred them to the Commissioner. The *Distribution Order* authorized the Commissioner to retain or dispose of these records at her discretion in accordance with the agency's records retention schedule. The Special Deputy Receiver requests that this

Court find that the Commissioner has authority to dispose of any or all records transferred to the Commissioner at her discretion.

VII. TERMINATION AND DISCHARGE

7.1 As all property of the First American receivership estate has been distributed, the Special Deputy Receiver requests the Court to enter an order pursuant to TEX. INS. CODE ANN. § 443.352 terminating this proceeding. The Special Deputy Receiver requests that this Court find that the Receiver and the Special Deputy Receiver are released from their duties in the First American receivership estate upon termination of this proceeding. The Special Deputy Receiver further requests that this Court enter an order discharging both the Receiver and the Special Deputy Receiver from their duties in the First American receivership estate upon termination of this proceeding.

7.2 In the event that a successor Commissioner is appointed prior to the entry of the order terminating this proceeding, Eleanor Kitzman shall be discharged as Receiver upon the end of her term as Commissioner, and her successor, if any, shall be discharged as Receiver upon the termination of this proceeding.

7.3 The Special Deputy Receiver requests a finding that the Receiver's predecessor, Mike Geeslin, has been discharged as a matter of law pursuant to TEX. INS. CODE ANN. § 443.151(a) and the *Liquidation Order*.

VIII. NOTICE & HEARING

8.1 The *Final Accounting Application* is filed pursuant to TEX. INS. CODE ANN. § 443.007. All of the provisions governing the procedure for addressing the *Final Accounting Application* are set out in TEX. INS. CODE ANN. § 443.007 and the *Order of Reference*. The subject matter of this *Final Accounting Application* has been referred to the receivership master appointed by this Court in this proceeding in compliance with the *Order of Reference*, Paragraph III, (30) and (32). The *Order of Reference* modifies the requirement for the amount of notice of a hearing contained in TEX. INS. CODE ANN. § 443.007(e) to fourteen calendar days. *Order of Reference*, pp. 6-7, Paragraph IV, 4(a).

8.2 The Special Deputy Receiver has provided notice of the hearing by submission for this *Final Accounting Application* to all parties in interest, as that term is defined in TEX. INS. CODE ANN. § 443.004(a)(17), and as shown on the certificate of service as well as persons the Special Deputy Receiver has determined need to be noticed under TEX. INS. CODE ANN. § 443.007(d). The Special Deputy Receiver has provided notice of the hearing by submission on the *Final Accounting Application* to all persons who have requested notice in the First American receivership estate in accordance with TEX. INS. CODE ANN. § 443.007(a) and the notice requirements in the *Order of Reference*. The Special Deputy Receiver requests that this Court find that notice of the hearing by submission on the *Final Accounting Application* to any party in interest does not confer standing in the Court to raise, appear, or be heard on any issue. The Special Deputy Receiver requests that this Court find that providing notice to parties in interest does not act to waive any rights, immunities, or privileges of the Special Deputy Receiver or the First American receivership estate.

8.3 The Special Deputy Receiver will provide notice of the hearing by submission on this *Final Accounting Application* by either electronic mail ("e-mail") or certified mail, as indicated by the certificate of service, to the parties described above, as authorized by TEX. INS. CODE ANN. § 443.007(d). The Special Deputy Receiver requests that the Court find that the notice given of the hearing by submission on this *Final Accounting Application* to the certificate of service complied with the Code and the *Order of Reference* and was sufficient.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Angenend & Augustine, P.C., as Special Deputy Receiver of First American Life Insurance Company, respectfully prays that this Court grant this *Final Accounting Application* and enter an Order:

- 1. Finding that the Special Deputy Receiver is authorized to file this *Final Accounting Application* pursuant to TEX. INS. CODE ANN. §§ 443.154 and 443.352;
- Finding that the Court has jurisdiction to hear this matter and that juridiction is properly in the 200th Judicial District Court of Travis County, Texas, as the court in which these delinquency proceedings are pending pursuant to TEX. INS. CODE ANN. § 443.005(c);
- 3. Finding that the subject matter of this *Final Accounting Application* has been referred to the receivership master appointed in this proceeding in accordance with Paragraph III, Sections 30 and 32 of the *Order of Reference;*
- 4. Authorizing the receivership master appointed under the *Order of Reference* to request and accept evidence in a hearing by submission to support the *Final Accounting Application;*
- 5. Accepting and approving, in all respects, this *Final Accounting and Application to Close Receivership and Discharge Receiver and Special Deputy Receiver*;
- 6. Admitting Exhibit A, the *Affidavit of Paul D. Angenend*, into evidence;
- 7. Admitting Exhibits B through Exhibit D into evidence;
- 8. Admitting the facts contained in the *Final Accounting Application* and all its exhibits, testified to and authenticated by Exhibit A, into evidence as *prima facie*

proof of the matters asserted pursuant to TEX. INS. CODE ANN. § 443.017(c);

- 9. Finding that the evidence submitted supports approval of the *Final Accounting Application;*
- 10. Finding that the Special Deputy Receiver has completed the distribution of assets and submitted its final accounting statements in Exhibits B, C, and D and final statement of expenses in Exhibit B;
- 11. Accepting Exhibits B, C, and D as the final accounting of financial reports for the First American receivership estate for this *Final Accounting Application*;
- 12. Accepting Exhibit B as the final statement of expenses for the First American receivership estate for this *Final Accounting Application*;
- Finding that there were no residual funds remaining to be distributed as any funds were distributed to the Special Deputy Receiver of Lincoln Memorial Life Insurance Company;
- 14. Finding that the final federal income tax return for 2012 was filed and no taxes are owed;
- 15. Finding that the Commissioner has authority to dispose of any or all records transferred to the Commissioner at her discretion;
- 16. Terminating the First American Life Insurance Company's receivership estate proceeding;
- 17. Finding that the Receiver and Special Deputy Receiver are released from their duties in the First American receivership estate upon termination of this proceeding;
- Discharging Commissioner Eleanor Kitzman as Receiver for First American Life Insurance Company;

- 19. Discharging Eleanor Kitzman as Receiver upon the end of her term as Commissioner, and discharging her successor, if any, as Receiver of the First American Life Insurance Company in the event that a successor Commissioner is appointed prior to the entry of the order terminating this proceeding;
- 20. Discharging Angenend & Augustine, P.C., as the Special Deputy Receiver for First American Life Insurance Company;
- 21. Finding that the Receiver's predecessor, Mike Geeslin, has been discharged as a matter of law pursuant to TEX. INS. CODE ANN. § 443.151(a) and the *Liquidation Order;*
- 22. Finding that the *Final Accounting Application* was properly submitted for hearing by submission before the receivership master pursuant to the *Order of Reference;*
- 23. Finding that the inclusion on the certificate of service of persons noticed satisfies the requirements for length and breadth of notice requirements pursuant to TEX.INS. CODE ANN. § 443.007(a) and (d) and the *Order of Reference*;
- 24. Finding that notice of the hearing by submission sent by e-mail or certified mail for this *Final Accounting Application* fulfills the notice requirements of the Code and the *Order of Reference* and is sufficient;
- 25. Finding that the notice of the hearing by submission on the *Final Accounting Application* to any party in interest does not confer standing in the Court to raise, appear, or be heard on any issue;
- 26. Finding that providing notice to parties in interest does not act to waive any rights, immunities, or privileges of the Special Deputy Receiver or the First American receivership estate;

- 27. Authorizing the Special Deputy Receiver to execute any documents and incur any administrative expenses as necessary to effectuate the purpose of this *Final Accounting Application;* and
- 28. Granting the Receiver and the Special Deputy Receiver such other and further relief to which they may be justly entitled.

- 3. The written objection must specifically list all reasons for objection with supporting references to and discussion of statutory and case authorities. Reasons not stated in writing will not be considered orally.
- 4. If a matter is set for hearing by submission, an objecting party shall expeditiously coordinate with Applicant's counsel and the receivership master's docket clerk [(512) 463-6450] to obtain an oral hearing, unless the receivership master determines that an oral hearing is not necessary. The objecting party shall serve a Notice of Oral Hearing on applicant's counsel and all interested parties, including those listed on the Applicant's Certificate of Service.
- 5. Failure to file timely a written objection before the receivership master constitutes a waiver of the right to object to the receivership master's recommendation to the District Court.
- 6. Any Acknowledgment of Notice and Waiver to be filed by any party in interest should be filed at least 3 calendar days before the submission or hearing date.

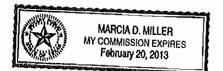
