**APPLICATION TO MAKE FINAL DISTRIBUTION AND DESTROY RECORDS**

TO THE HONORABLE JUDGE OF THIS COURT

CANTILO & BENNETT, L.L.P., Special Deputy Receiver of Santa Fe Auto Insurance Company (the “SDR” and “Santa Fe” respectively), files this *Application to Make Final Distribution and Destroy Records* (the “Application”).

**I. INTRODUCTION**

1.1 The SDR has completed all claims processing and asset collection activities in this proceeding. The SDR requests this Court to authorize it to make a final distribution of the receivership’s assets and dispose of or transfer any remaining Santa Fe records. Following the completion of the final distribution, the transfer and destruction of records, and the filing of the final tax return(s) and issuance of any other required tax documents, the SDR will submit an application to dissolve the charter of Santa Fe, discharge the Receiver and the SDR, transfer any remaining assets, and terminate this proceeding.

**II. AUTHORITY**

2.1 The SDR is authorized to file this Application pursuant to § 443.302 and § 443.354 of the Texas Insurance Code.<sup>1</sup> Under § 443.154(a), the SDR has all of the Receiver’s powers,

except as limited by the Receiver.

2.2 The subject matter of this Application is referred to the Special Master appointed in this proceeding in accordance with the *Amended Order of Reference to Master* entered on April 5, 2013.

### III. BACKGROUND

#### A. Company History

3.1 Santa Fe was a Texas domiciled insurance company operating under Chapter 822. Santa Fe wrote private passenger nonstandard automobile liability and physical damage policies in Texas, Arizona, Arkansas, Georgia, Oklahoma, New Mexico, Nevada, and Utah.

#### B. Initiation of Receivership Proceeding and Appointment of Rehabilitator

3.2 On March 8, 2013, the Court entered an *Order Appointing Rehabilitator and Permanent Injunction*, appointing the Texas Commissioner of Insurance (the “Commissioner”) as Rehabilitator of Santa Fe.

#### C. Appointment of Special Deputy Receiver

3.3 Effective March 8, 2013, the Rehabilitator appointed CANTILO & BENNETT, L.L.P., as SDR of Santa Fe.

#### D. Referral to Master

3.4 On March 18, 2013, this Court issued its *Order of Reference to Master* appointing Tom Collins as Special Master in this proceeding.

#### E. Conversion to Liquidation

3.5 On April 5, 2013, the Court entered an *Order Appointing Liquidator and Permanent Injunction*, placing Santa Fe in liquidation, and its *Amended Order of Reference to*

*Master.* In accordance with § 443.151, the Commissioner was appointed Liquidator. All of the Commissioner's predecessors have been discharged as a matter of law.

3.6 The Commissioner designated Santa Fe an "impaired insurer" under Chapter 462 effective April 5, 2013. The Texas Property and Casualty Insurance Guaranty Association ("TPCIGA") and guaranty associations in Arkansas, Arizona, Georgia, Nevada, New Mexico, Oklahoma and Utah (collectively, the "Affected IGAs") became responsible for "covered claims" in accordance with their states' governing statutes.

#### **IV. FINANCIAL STATEMENTS**

4.1 The Statements of Net Assets and Net Liabilities for the receivership, attached as Exhibits 1-A and 1-B, respectively, are incorporated herein by reference, and reflect the financial condition of the receivership as of August 31, 2020. The consolidated Sources and Uses of Cash Statement, which lists all funds received and disbursed from the date of receivership to August 31, 2020, is attached as Exhibit 2 and incorporated herein by reference. These exhibits represent the financial reports for the receivership in accordance with § 443.016.

#### **V. DISPOSITION OF ASSETS**

5.1 The Disposition of Assets schedule is attached as Exhibit 3 and incorporated herein by reference. The schedule sets forth all asset transactions since March 8, 2013 and reflects total assets of Santa Fe as of August 31, 2020. The SDR has determined that there are no contingent assets and no uncollectible assets. Upon the termination of this proceeding, all unknown assets will be transferred to the Commissioner.

## VI. CLAIMS

### A. Notice

6.1 On July 19, 2013, this Court entered its *Order Granting Application to Approve Notice and Setting Claims Filing Deadlines* (the “POC Order”) establishing October 5, 2014 as the claims filing deadline. In accordance with the POC Order, the SDR provided notice of the claim filing deadline to all persons who may have had claims as shown by Santa Fe’s books and records. In addition, in accordance with the order, the SDR published notice of the claim filing deadline in newspapers of general circulation in the major cities in the states where Santa Fe was licensed to sell insurance, including Dallas; Houston; Salt Lake City; Atlanta; Oklahoma City; Las Vegas; Little Rock, Arkansas; and Albuquerque, New Mexico.

### B. Filing of Claims

6.2 The SDR issued approximately 17,492 Proof of Claim (“POC”) notices and received or deemed 3,204 POCs.

### C. Claims Processing

6.3 All POCs against the receivership estate were adjudicated pursuant to § 443.253(b) with respect to their classification and all claims with a Class 2 priority and higher were adjudicated as to their amount. POCs with a Class 3 or lower priority were adjudicated as to classification only pursuant to § 443.253(k). The period of time allowed by § 443.253(c) to appeal the SDR’s determinations on these claims has expired, and the Receivership Court has approved the SDR’s Report of Claims. The POCs were classified as follows<sup>2</sup>:

**D. Claims Report**

6.4 On June 19, 2019, the Receivership Court approved the SDR's Report of Claims (attached as Exhibit 4) pursuant to § 443.258. Allowed claim amounts are included on the Statement of Net Liabilities, attached as Exhibit 1-B.

**E. Distributions**

6.5 The SDR distributed \$10,693,965.66 in two early access distributions during the receivership consisting of \$2,757,574.82 on or about August 25, 2014, and \$7,500,000 on or about May 31, 2016, and credited \$436,390.84 in statutory deposits.

**VII. EXPENSES**

**A. Paid Expenses**

7.1 The administrative expenses of the Liquidator and SDR have been paid through August 31, 2020. On May 8, 2013, this Court approved the terms of compensation of the SDR and other contractors pursuant to § 443.015. The compensation and expenses have been paid in accordance with that order through August 31, 2020.

**B. Closing Expenses**

7.2 The SDR proposes to reserve \$117,822 for the payment of estimated expenses involved in closing the receivership, including some obligations that continue past closing, as reflected on the detailed breakdown of estimated closing expenses, attached as Exhibit 5. The SDR requests approval of the reserve for closing expenses as reflected on Exhibit 5.

**C. Final Statement of Expenses**

7.3 Pursuant to § 443.015, the SDR will submit a detailed final statement of the actual expenses incurred when the SDR files the verified application to terminate the estate. If the actual expenses differ from the amount reserved, the excess funds or the shortfall (as applicable) will be handled as described in this Application. The SDR will file a final accounting including the final distribution schedule and a final statement of expenses that reflects the actual expenses incurred.

**VIII. DISTRIBUTION OF ASSETS**

**A. Assets Available for Distribution**

8.1 As of August 31, 2020, the receivership estate's accounts held \$4,795,660 in cash. After paying for Class 1 administrative expenses incurred in August 2020 totaling \$21,116 and reserving for the remaining administrative expenses through closing as described above, \$4,656,722 will be available for distribution.

**B. Eligible Claimants**

8.2 There are sufficient assets to pay all approved Class 1 claims in full and to make a 37.33% distribution to Class 2 claims. There will be no distributions to claims with a priority lower than Class 2. Attached as Exhibit 6 is a Distribution Schedule listing all approved claimants to whom a distribution will be made. This exhibit identifies each claimant's name as shown on the POC, the amount approved by the SDR, and the projected distribution. The projected distribution is an approximate figure based on current financial data, and the actual distribution may vary from this projection. The SDR requests that the Court approve the projected distribution and authorize it to distribute the assets of the receivership estate as described in this Application and Exhibit 6.

**C. Distribution Process**

8.3 Distribution Notices will be mailed to all claimants with approved Class 2 claims who are not on the service list, advising them of the proposed distribution. The Distribution Notice attached as Exhibit 7A, which will be sent to claimants who will receive distributions, explains the calculation of the distribution and the payment process. The Distribution Notice attached as Exhibit 7B, which will be sent to claimants who will not receive distributions, notifies them that payment will not be made because the distribution amount would be *de minimis*. Both Distribution Notices include the same information about objecting to the Application. The Distribution Notices will be mailed to the address provided by the claimant in the POC, or any subsequent address provided by the claimant.<sup>3</sup> After the Court approves this Application, distributions will be made by wire transfer, if feasible, or by mailing a cashier's check by first class mail to the address provided by the claimant. In the event that a Distribution Notice is returned by the Post Office with an address correction, the SDR will send the distribution check to the corrected address.

**D. De Minimis Distributions**

8.4 Section 443.253(h) provides for the disallowance of claims for *de minimis* amounts, as determined by this Court. The SDR proposes to establish a distribution threshold of \$25, which is reasonable and necessary for cost-effective administration. The SDR asks this Court to find that any distribution below the proposed threshold be considered *de minimis* and authorize the SDR to withhold the amount of any such distribution and treat such funds as "Residual Funds."

**E. Residual Funds**

8.5 It is possible that there may be additional funds in the receivership account after the distribution (“Residual Funds”). Such funds may result from interest on the receivership account, excess reserves for closing expenses, or the collection of assets after the distribution has commenced. Such funds will be handled as described below.

**F. Supplemental Distribution**

8.6 If it is economically feasible to distribute Residual Funds, the SDR will make a supplemental distribution from any such residual funds, after reserving for distribution expenses. Any supplemental distribution will be subject to the *de minimis* distribution threshold approved by the Court.

**G. Transfer of Remaining Funds**

8.7 Section 443.352 provides this Court may issue an order to transfer funds remaining after the final distribution that cannot be distributed economically. In the event that there are any funds remaining after the final distribution and it is not economically feasible to distribute such funds, the SDR requests that such funds be transferred to the Commissioner for deposit in an account established under § 443.304(c) or other applicable law. Such funds will be available to pay any expenses exceeding the expense reserve or expenses incurred for activities after the closing of the receivership, such as responding to inquiries and handling unclaimed funds. The SDR requests that this Court authorize it to transfer to the Commissioner any such Residual Funds remaining after all distributions are made.



## **IX. UNCLAIMED FUNDS**

### **A. Unclaimed Distributions**

9.1 The SDR will maintain the receivership's distribution bank account for forty-five (45) days after the final distribution or until all distributions have been received by wire transfer or checks cashed, whichever is earlier. This will provide a reasonable amount of time for claimants to receive their funds and/or deposit their checks. The SDR will deliver any funds which are unclaimed as of the closing of the account to the Commissioner as required by § 443.304(a) to be placed in a segregated unclaimed funds account.

9.2 In the event that a Distribution Notice is mailed to an address and returned as undeliverable, the SDR requests that this Court order that any distribution due to such a claimant should be treated as unclaimed without the need for the estate to incur the expense of mailing an undeliverable check. The SDR proposes that all distributions to such claimants be withheld from the mailing of the final distribution and be delivered to the Commissioner upon closing of the account as described in this Application.

## **X. RECORDS**

### **A. Disposal of Records**

10.1 Certain records of Santa Fe will be retained by the Commissioner after the termination of this proceeding, as described below (retained records). All other records of Santa Fe will not be needed upon the termination of this proceeding. The SDR requests authority under § 443.354(a) to destroy these records.

### **B. Records Transferred to Commissioner**

10.2 Records that may be required after the termination of this proceeding will be delivered to the Commissioner pursuant to § 443.354(b) and maintained in compliance with the

Receiver's records retention policy for receivership records. The SDR requests that the Court authorize the Commissioner to retain or dispose of these records at his or her discretion.

#### **XI. TAX RETURNS**

11.1 The SDR has filed income tax returns with the Internal Revenue Service for years 2013 through 2019. The SDR will file the final 2020, and if necessary, the 2021, tax return for Santa Fe after the distribution of assets and before the SDR is discharged. No taxes are owed to the Internal Revenue Service.

#### **XII. CERTIFICATION OF CLOSING ACTIVITIES**

12.1 Before or when the SDR files an application to terminate the estate and be discharged, the SDR will file a certification with the Special Master which includes copies of the final tax return(s) and a release from the federal government, together with the final accounting of all funds in the estate.

#### **XIII. CHARTER AND LICENSES**

13.1 The SDR has determined that a sale of the charter and license of Santa Fe is not feasible. The SDR requests that this Court dissolve the charter pursuant to § 443.153(e) on the termination of this proceeding.

#### **XIV. OFFER OF PROOF**

14.1 This Application is verified by the affidavit and certification pursuant to § 443.017(b) by Susan E. Salch, designated representative of CANTILO & BENNETT, L.L.P., as SDR of Santa Fe Auto Insurance Company.

## XV. NOTICE

### A. Notice

15.1 In accordance with § 443.007(d) and the *Amended Order of Reference*, the SDR served this Application at least 14 days before the submission date on (i) parties that filed an appearance in this proceeding and (ii) other parties as determined by the SDR as shown on the Certificate of Service.

### B. Distribution Notice

15.2 The Distribution Notices attached as Exhibits 7A and 7B will be sent at least 14 days before the submission date of the Application to the Class 2 claimants described in Paragraphs 8.3 and 8.4 who are not on the service list. Claimants with approved claims with a priority lower than Class 2 will not be sent a Distribution Notice. The POC determination letter for these claimants advised that the SDR did not anticipate making distributions on claims with a priority level below Class 2.

## PRAYER

WHEREFORE, PREMISES CONSIDERED, CANTILO & BENNETT, L.L.P., Special Deputy Receiver of Santa Fe Auto Insurance Company, respectfully prays that this Court enter an Order:

1. Accepting and approving the final financial statements;
2. Approving in all respects the Application;
3. Approving the estimated expenses through the closing of the receivership pursuant to § 443.015;
4. Authorizing the SDR to distribute the cash assets of the receivership as described in the Application and authorizing the SDR to withhold any distribution under \$25 as *de minimis*;

5. Authorizing the SDR to deliver all unclaimed funds to the Commissioner, and finding that any distribution to a claimant for whom the Distribution Notice was returned as undeliverable shall be deemed as unclaimed for purposes of § 443.304;
6. Authorizing the SDR to deliver all Residual Funds to the Commissioner;
7. Authorizing the SDR to dispose of the records as described in the Application and deliver any remaining records to the Commissioner, and authorizing the Commissioner to maintain or dispose of such records at his or her discretion;
8. Dissolving the corporate entity and charter of Santa Fe upon termination of this proceeding;
9. Authorizing the SDR to file any required tax returns, including filing the final tax return after the termination of the estate; and
10. Granting such further relief to which the SDR or Liquidator may be entitled.

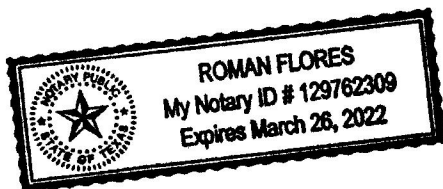
