General remarks and official action taken:

The subject of this default order is whether an adjuster all lines agent license should be issued to Michael Alex Davidson (Respondent). Respondent did not appear at the hearing on the merits. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Appear at Hearing on the Merits

- 1. On January 3, 2024, the Texas Department of Insurance (TDI) filed a Notice of Hearing, attached as Exhibit A, together with a previously filed Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. TDI's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. TDI sent the Notice of Hearing and Original Petition together to Respondent's last known address provided in writing to TDI,

 The Notice of Hearing and Original Petition were also sent by electronic mail.

4. After receiving proper notice of the date, time and location of the hearing on the merits, Respondent failed to appear for the hearing on February 29, 2024, as shown in the record in SOAH Docket No. 454-24-07470.C.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to appear in person or by legal representative at the hearing, TDI is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to deny Michael Alex Davidson's (Davidson) license application. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

The commissioner of insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. On August 14, 2023, Davidson applied for an adjuster all lines agent license. Davidson disclosed his criminal history on his license application.
- 2. On September 20, 2023, TDI proposed to deny Davidson's license application due to his criminal history. Davidson requested a hearing on the denial.

Criminal History

3. On November 13, 2020, in the Circuit Court of the Second Judicial Circuit, in and for Leon County, Florida, Case No. 19CF002168A, Davidson pleaded nolo contendre to one count of False Imprisonment, one count of Domestic Battery by Strangulation, and one count of Tampering with a Witness or Informant. All three counts were third degree felonies.

- 4. The court withheld adjudication on all three counts and placed Davidson on 12 months community control followed by 36 months of probation.
- 5. Davidson is expected to be on probation until November 2024.

Legal Allegations

- 1. Pursuant to Tex. Occ. Code § 53.021(d)(1)(B)(i) and (d)(2)(A-B), TDI may consider Case No. 19CF002168A to be a felony conviction.
- 2. TDI may deny Davidson's license application because he has been convicted of an offense that directly relates to the duties and responsibilities of the licensed occupation, as contemplated by Tex. Occ. Code §§ 53.021(a)(1), 53.022, 53.023, and 28 Tex. Admin. Code § 1.502(d).
- 3. TDI may deny Davidson's license application because he has committed a felony, as contemplated by 28 Tex. ADMIN. CODE § 1.502(d).
- 4. TDI may deny Davidson's license application because he committed an offense of such serious nature that it is of prime importance in determining fitness for licensure, as contemplated by 28 Tex. ADMIN. CODE §§ 1.502(e)(3), (e)(4)(B), and (e)(4)(H).
- 5. The factors listed under 28 Tex. ADMIN. CODE § 1.502(h) do not outweigh the serious nature of Davidson's criminal history, as 28 Tex. ADMIN. CODE § 1.502(f) contemplates.

¹ After Davidson submitted his application, 28 Tex. Admin. Code § 1.502 was amended, effective September 26, 2023. Accordingly, all references and citations to 28 Tex. Admin. Code § 1.502 in this Petition are made to the version in effect at the time Davidson's application was submitted.
