










CY2021 Cases Pending by Subject



CY2021 Cases Closed by Subject Type



Utilization Review Agent Plan-Based Audit

- Audit completed in 2021
 - Adherence to ODG and medical standards of care for conducting utilization review when approving spinal lumbar fusions.
 - Appropriate selection of reviewing health care providers.
- 30 cases selected and reviewed
- 13 cases closed with no action
- 17 cases referred to enforcement

Shoulder Surgery Plan-Based Audit

- Audit adopted December 2021
- Adherence to ODG and medical standards of care for performing acromioplasty or distal clavicle resection procedures conducted as part of a shoulder rotator cuff repair
- Appropriate medical recordkeeping
- 10 subjects to be selected with five random cases

CY2022 Annual Audit

- Audit adopted December 2021
- Two review categories:
 - Evaluate the reasonableness of a doctor's decision and recordkeeping regarding RTW.
 - Evaluate the appropriateness of a health care provider's decision-making and recordkeeping that supports the use and effectiveness of spinal cord stimulators.



COVID-19 Workers' Compensation Claims in Texas

- Data sources:
 - claim and medical EDI for workers' compensation claims
 - COVID-19 data call
 - COVID-19 case data collected by Texas Department of State Health Services
- Analysis timeframe: COVID-19 claims reported to an insurer as of September 30, 2021
- More than 61,000 claims identified, including 371 fatalities and 134 disputes filed as of November 7, 2021.

Number of COVID-19 Claims by Month Insurance Carrier Received Claim Notice




COVID-19 Claims by Occupation






