\* Current DWC rules allow a certifying doctor to bill for the first musculoskeletal area at \$150 if the DRE (diagnosis-related estimate) method is used, or \$300 if the range of motion method is used to determine IR. DWC is proposing to eliminate the two different billing methods and set the rate for the first musculoskeletal area at \$360, regardless of which method is used.
