1	Yes	These products satisfy TDI's criteria for protection from windborne debris in the Inland I and Seaward zone. Install the assemblies at a height on the structure that does not exceed the design pressure rating for the assemblies.

Installation:

System 1: Use minimum Southern Yellow Pine dimension lumber. The window is secured to the wall framing using minimum No. 8 screws. The fasteners are driven through the reinforcement channel and vinyl frame and into the wall framing. The fasteners are spaced 6" from each corner and 12" on center along the head and the sill. The fasteners are spaced 6" from each corner and 14" on center along the side jambs. The fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC, the IBC, and the Texas Revisions.
