Installation:

Option 1 (Nail Fin): The wood wall framing members shall be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing using the nailing fin on the window. The nailing fin is secured to the wall framing with either minimum No. 8 x 2" screws or minimum 2 ⅜" x 0.120" diameter smooth shank nails. The fasteners shall be spaced approximately 8 inches from each corner and approximately 8 inches on center along perimeter of the window. The fasteners shall be long enough to penetrate a minimum of 1 ½ inches into the wall framing members.

Option 2 (Frame Installation): The wood wall framing members shall be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing using the frame of the window. The window frame is secured to the wall framing with minimum No. 8 x 2" screws. Along the side jambs, a minimum of five (5) fasteners (six (6) for System 1) are required, evenly spaced with one (1) fastener located approximately 6 inches from each end. Along the head and the sill, three (3) fasteners are required, one (1) located approximately 6 inches from each end and one (1) at the mid span. The fasteners shall be long enough to penetrate a minimum of 1 ½ inches into the wall framing members.

Note: The manufacturer's installation instructions shall be available on the job site during installation. All fasteners shall be corrosion resistant as specified in the International Residential Code (IRC), the International Building Code (IBC), and the Texas Revisions.
