## FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

## **Background**

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §133.240 sets out requirements of medical necessity notification.
- 3. 28 Texas Administrative Code §134.502 sets out the procedures for pharmaceutical benefits.
- 4. 28 Texas Administrative Code §134.503 sets out the fee guidelines for pharmaceutical services.
- 5. The carrier denied with the following claim adjustment codes:
  - 50 These are non-covered services because this is not deemed a medical necessity by the payer

#### Issues

- 1. Did carrier's follow DWC guidelines?
- 2. Is the requestor entitled to reimbursement for the compound in question?

### **Findings**

- 1. The requestor is seeking reimbursement of \$714.75 for services rendered on February 12, 2018. The carrier denied as 50 "These are on-covered services because this is not deemed a medical necessity by the payer."
  - 28 TAC §133.240 (q) states

When denying payment due to an adverse determination under this section, the insurance carrier shall comply with the requirements of §19.2009 of this title (relating to Notice of Determinations Made in Utilization Review). Additionally, in any instance where the insurance carrier is questioning the medical necessity or appropriateness of the health care services, the insurance carrier shall comply with the requirements of §19.2010 of this title (relating to Requirements Prior to Issuing Adverse Determination), including the requirement that prior to issuance of an adverse determination the insurance carrier shall afford the health care provider a reasonable opportunity to discuss the billed health care with a doctor or, in cases of a dental plan or chiropractic services, with a dentist or chiropractor, respectively.

Review of the submitted documentation found insufficient evidence to support the requirements of the above stated rule were met. The carriers' denial for medical necessity will not be considered in this review.

- 2. 28 TAC §134.503 applies to the compounds in dispute and states, in pertinent part:
  - (c) The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:
    - (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
      - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;
      - (B) Brand name drugs: ((AWP per unit) x (number of units) x 1.09) + \$4.00 dispensing fee per prescription = reimbursement amount;
      - (C) When compounding, a single compounding fee of \$15 per prescription shall be added to the calculated total for either paragraph (1)(A) or (B) of this subsection;

The total reimbursement is \$675.58. This amount is recommended.

#### **Conclusion**

For the reasons stated above, DWC finds that the requestor has established that additional reimbursement is due. As a result, the amount ordered is \$675.58.

#### ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031 and 413.019 (if applicable), DWC has determined the requestor is entitled to additional reimbursement for the disputed services. The division hereby ORDERS the respondent to remit to the requestor \$675.58, plus applicable accrued interest per 28 TAC §134.130, due within 30 days of receipt of this order.

#### YOUR RIGHT TO APPEAL

The request must be received by the division within **twenty** days of your receipt of this decision. The request may be faxed, mailed or personally delivered to the division using the contact information listed on the form or to the field office handling the claim.
