<u>Requestor's Position Summary</u>: "The above claimant received medication and the carrier still has not acknowledged receipt of service. The original bill was submitted to carrier on <u>04/24/2018.</u>"

Amount in Dispute: \$602.97

RESPONDENT'S POSITION SUMMARY

Respondent's Position Summary: "The 4/19/18 compound medication was not denied as requiring preauthorization, as investigational or as experimental. It was denied as not medically necessary following completion of a retrospective medical necessity review. Per peer Review: "The rationale behind prescribing these medications is purely empiric."

FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 1. 28 Texas Administrative Code §133.240 sets out the general medical provisions for medical payments and denials.
- 2. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 3. 28 Texas Administrative Code §134.502 sets out the procedures for pharmaceutical benefits.
- 4. 28 Texas Administrative Code §134.503 sets out the fee guidelines for pharmaceutical services.
- 5. 28 Texas Administrative Code §134.530 sets out the closed formulary requirements for claims not subject to

certified networks.

- 6. 28 Texas Administrative Code §19.2009 sets out the notice of determinations made in utilization review.
- 7. 28 Texas Administrative Code §19.2010 sets out the requirements prior to issuing adverse determination.
- 8. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - X435 Based on peer review, further treatment is not recommended. For TX jurisdiction claims only, per TX Labor Code Sec 413.031 and 28 TAC Sections 133.308(H), (I), after reconsideration you may seek review of a denial

<u>Issues</u>

- 1. Is Liberty Insurance Corp's reason for denial of payment supported?
- 2. Is Memorial Compounding Pharmacy entitled to reimbursement for the compound in question?

Findings

1. Memorial is seeking reimbursement for drug(s)] dispensed on April 19, 2018.

Liberty Insurance Corp denied the disputed drugs with claim adjustment reason code X435 – "Based on peer review, further treatment is not recommended. For TX jurisdiction claims only, per TX Labor Code Sec 413.031 and 28 TAC Sections 133.308(H), (I), after reconsideration you may seek review of a denial."

28 Texas Administrative Code §133.305(b) requires that "If a dispute regarding...medical necessity exists for the same service for which there is a medical fee dispute, the disputes regarding...medical necessity shall be resolved prior to the submission of a medical fee dispute for the same services in accordance with Labor Code §413.031 and §408.021."

28 Texas Administrative Code §133.240(q) states that the insurance carrier is required to comply with 28 Texas Administrative Codes §19.2009 and 19.2010 when denying payment based on an adverse determination.

The division concludes that the submitted document that states, "This opinion does not constitute a recommendation for specific claims or administrative function to be made or enforced, nor does it constitute an adverse or affirming decision as it relates to acceptance or denial of retrospective, concurrent or prospective medical treatment." The division concludes that this document does not meet the requirements of 28 Texas Administrative Code §133.240(q).

Liberty Insurance Corp's denial reason is therefore not sufficiently supported. The disputed drug(s) will consequently be reviewed per applicable guidelines.

- 2. 28 Texas Administrative Code §134.503 applies to the compounds in dispute and states, in pertinent part:
 - (c) The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:
 - (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
 - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (B) Brand name drugs: ((AWP per unit) x (number of units) x 1.09) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (C) When compounding, a single compounding fee of \$15 per prescription shall be added to the calculated total for either paragraph (1)(A) or (B) of this subsection; or
 - (2) notwithstanding §133.20(e)(1) of this title (relating to Medical Bill Submission by Health Care Provider), the amount billed to the insurance carrier by the:
 - (A) health care provider; or
 - (B) pharmacy processing agent only if the health care provider has not previously billed the insurance carrier for the prescription drug and the pharmacy processing agent is billing on behalf of the health care provider.

The drugs in dispute was billed by listing each drug included in the compound and calculating the charge for each drug separately as required by 28 Texas Administrative Code §134.502(d)(2). Each ingredient is listed below with its corresponding reimbursement amount as applicable.

The total reimbursement is therefore \$553.77. This amount is recommended.

Conclusion

For the reasons stated above, the Division finds that the requestor has established that reimbursement is due. As a result, the amount ordered is \$553.77.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031 and 413.019 (if applicable), the division has determined the requestor is entitled to additional reimbursement for the disputed services. The division hereby ORDERS the respondent to remit to the requestor \$553.77, plus applicable accrued interest per 28 Texas Administrative Code §134.130, due within 30 days of receipt of this order.

A party seeking review must submit a **Request to Schedule a Benefit Review Conference to Appeal a Medical Fee Dispute Decision** (form **DWC045M**) in accordance with the instructions on the form. The request must be received by the division within **twenty** days of your receipt of this decision. The request may be faxed, mailed or personally delivered to the division using the contact information listed on the form or to the field office handling the claim.

The party seeking review of the MFDR decision shall deliver a copy of the request to all other parties involved in the dispute at the same time the request is filed. **Please include a copy of the** *Medical Fee Dispute Resolution Findings and Decision* together with any other required information specified in 28 Texas Administrative Code §141.1(d).
