REQUESTOR'S POSITION SUMMARY

<u>Requestor's Position Summary:</u> "The carrier denied the reconsideration based on lack of preauthorization or preauthorization was absent. These medications do not require preauthorization therefore do not need a retrospective review."

Amount in Dispute: \$702.68

Respondent's Position Summary: "The request should be dismissed for the following reasons: The provider's proper venue for disagreeing with a medical necessity denial is an independent review organization."

FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §134.503 sets out the fee guidelines for pharmaceutical services.
- 3. 28 Texas Administrative Code §134.530 sets out prior authorization requirement for pharmacy services.

- 4. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - 197 Payment denied/reduced for absence of precertification/preauthorization

<u>Issues</u>

- 1. Did the insurance carrier raise a new issue?
- 2. Is the insurance carrier's reason for denial of payment supported?
- 3. Is the requestor entitled to reimbursement for the compound in question?

Findings

1. The respondent states in their position, "The provider's proper venue for disagreeing with a medical necessity denial is an independent review organization" and "The respondent included the statement, "...Since Rule 134.600 (p)(11) requires preauthorization for all drugs not included in the applicable division formulary, compound drugs require preauthorization."

28 TAC §133.307 (d) (2) (F) states in pertinent part,

The response shall address only those denial reasons presented to the requestor prior to the date the request for MFDR was filed with the division and the other party. Any new denial reasons or defenses raised shall not be considered in the review.

Review of the submitted documentation found insufficient documentation to support the insurance carrier presented either of the mentioned denials for the date of service in dispute prior to MFDR. Based on the above this position will not be considered in this review.

2. The requestor is seeking reimbursement of \$702.68 for a compound dispensed March 14, 2018. The insurance carrier denied based on lack of pre-authorization.

28 Texas Administrative Code §134.530(b)(1)(A) states that preauthorization is **only** required for:

- drugs identified with a status of "N" in the current edition of the ODG Treatment in Workers' Comp
 (ODG) / Appendix A, ODG Workers' Compensation Drug Formulary, and any updates;
- any compound that contains a drug identified with a status of "N" in the current edition of the ODG
 Treatment in Workers' Comp (ODG) / Appendix A, ODG Workers' Compensation Drug Formulary, and
 any updates; and
- any investigational or experimental drug for which there is early, developing scientific or clinical
 evidence demonstrating the potential efficacy of the treatment, but which is not yet broadly
 accepted as the prevailing standard of care as defined in Labor Code §413.014(a).

The division finds that the compound rendered on the date of service in question does not include a drug identified with a status of "N" in the current edition of the ODG, *Appendix A*. The compound in question did not require preauthorization and the carrier's denial of payment for this reason is not supported. The disputed compound will be reviewed for reimbursement.

- 3. 28 Texas Administrative Code §134.503 (c) applies to the compounds in dispute and states, in pertinent part:
 - (c) The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:
 - (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
 - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (B) Brand name drugs: ((AWP per unit) x (number of units) x 1.09) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (C) When compounding, a single compounding fee of \$15 per prescription shall be added to the calculated total for either paragraph (1)(A) or (B) of this subsection; or

Based on the submitted information, pursuant to Texas Labor Code Section 413.031 and 413.019 (if applicable), the division has determined the requestor is entitled to additional reimbursement for the disputed services. The division hereby ORDERS the respondent to remit to the requestor \$702.68, plus applicable accrued interest per 28 Texas Administrative Code §134.130, due within 30 days of receipt of this order.
