FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §134.503 sets out the fee guidelines for pharmaceutical services.
- 3. 28 Texas Administrative Code §134.530 sets out prior authorization requirement for pharmacy services.
- 4. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - 197 Precertification/authorization absent

<u>Issues</u>

- 1. Is the insurance carrier's reason for denial of payment supported?
- 2. Is the requestor entitled to reimbursement for the compound in question?

Findings

- 1. The requestor is seeking reimbursement of \$726.62 for a compounded medication dispensed on May 16, 2018. The insurance carrier denied stating prior authorization was required.
 - 28 Texas Administrative Code §134.530(b)(1)(A) states that preauthorization is **only** required for:
 - (1) Preauthorization is only required for:
 - (A) drugs identified with a status of "N" in the current edition of the ODG Treatment in Workers' Comp (ODG) / Appendix A, ODG Workers' Compensation Drug Formulary, and any updates;
 - (B) any prescription drug created through compounding prescribed before July 1, 2018 that contains a drug identified with a status of "N" in the current edition of the ODG Treatment in Workers' Comp (ODG) / Appendix A, ODG Workers' Compensation Drug Formulary, and any updates;
 - (C) any prescription drug created through compounding prescribed and dispensed on or after July 1, 2018; and
 - (D) any investigational or experimental drug for which there is early, developing scientific or clinical evidence demonstrating the potential efficacy of the treatment, but which is not yet broadly accepted as the prevailing standard of care as defined in Labor Code §413.014(a).

Review of the submitted medical bill found none of the medication is listed as a "N" drug in Appendix A of the ODG Workers' Compensation Drug Formulary, the date of service is prior to July 1, 2018 and investigation and experimental was not supported by a utilization review findings. The insurance carrier's denial is not supported. The services will be reviewed based on current fee guidelines.

- 2. 28 Texas Administrative Code §134.503 (c) applies to the compounds in dispute and states, in pertinent part:
 - (c) The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:
 - (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
 - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (B) Brand name drugs: ((AWP per unit) x (number of units) x 1.09) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (C) When compounding, a single compounding fee of \$15 per prescription shall be added to the calculated total for either paragraph (1)(A) or (B) of this subsection; or

The division hereby ORDERS the respondent to remit to the requestor \$726.62, plus applicable accrued interest per 28 Texas Administrative Code §134.130, due within 30 days of receipt of this order.
