FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §134.403 sets out the reimbursement guidelines for outpatient hospital services.
- 3. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - 802 Charge for this procedure exceeds the OPPS schedule allowance

<u>Issues</u>

- 1. What is the applicable rule for determining reimbursement for the disputed services?
- 2. Is the requestor entitled to additional reimbursement?

Findings

- 1. The requestor is seeking additional reimbursement in the amount of \$22.03 for outpatient hospital services rendered on August 17, 2018. The insurance carrier reduced disputed services with claim adjustment reason code 802 "Charge for this procedure exceeds the OPPS schedule allowance."
 - 28 Texas Administrative Code §134.403 (f) states,

The reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually in the *Federal Register*. The following minimal modifications shall be applied.

- (1) The sum of the Medicare facility specific reimbursement amount and any applicable outlier payment amount shall be multiplied by:
 - (A) 200 percent; unless
 - (B) a facility or surgical implant provider requests separate reimbursement in accordance with subsection (g) of this section, in which case the facility specific reimbursement amount and any applicable outlier payment amount shall be multiplied by 130 percent.

Review of the submitted medical bill found implants were not applicable to this bill. The maximum allowable reimbursement is calculated as follows:

- Procedure code 36569 has status indicator T, for procedures subject to multiple-procedure reduction. The highest paying status T unit is paid at 100%; all others at 50%. This code is paid at 100%. This code is assigned APC 5182. The OPPS Addendum A rate is \$982.97, multiplied by 60% for an unadjusted labor amount of \$589.78, in turn multiplied by the facility wage index of 0.9636 for an adjusted labor amount of \$568.31. The non-labor portion is 40% of the APC rate, or \$393.19. The sum of the labor and non-labor portions is \$961.50. The Medicare facility specific amount of \$961.50 is multiplied by 200% for a MAR of \$1,923.00.
- 2. The total recommended reimbursement for the disputed services is \$1,923.00. The insurance carrier paid \$1,899.54. The requestor is seeking additional reimbursement of \$22.03. This amount is recommended.

Conclusion

For the reasons stated above, the Division finds that the requestor has established that additional reimbursement is due. As a result, the amount ordered is \$22.03.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031 and 413.019 (if applicable), the division has determined the requestor is entitled to additional reimbursement for the disputed services. The division hereby ORDERS the respondent to remit to the requestor \$22.03, plus applicable accrued interest per 28 Texas Administrative Code §134.130, due within 30 days of receipt of this order.
