REQUESTOR'S POSITION SUMMARY

<u>Requestor's Position Summary</u>: "The bill and appeal were denied for timely filing. The Remittance from USAA was attached as proof of timely filing. We did not learn of Texas Mutual Insurance claim until 11/15/18."

RESPONDENT'S POSITION SUMMARY

Respondent's Position Summary: "Texas Mutual on 11/29/18 received the bill from East Texas medical Center. Texas Mutual reviewed the bill and attached documentation then denied payment absent a timely bill submission. That review showed that USAA is not an insurer that issues a policy or group accident and health insurance under which the injured employee is a covered insured; a health maintenance organization that issues an evidence of coverage under which the injured employee is a covered enrollee; or a workers' compensation insurance carrier other than the insurance carrier liable for the payment of benefits under this title. No payment is due."

FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.

- 2. 28 Texas Administrative Code §133.20 sets out requirements of medical bill submission.
- 3. Texas Labor Code 408.0272 sets out the workers compensation timely billing and exceptions guidelines.
- 4. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - 29 The time limit for filing has expired

<u>Issues</u>

1. Are the insurance carrier's reasons for denial of payment supported?

Findings

- 1. The requestor is seeking \$579.01 for outpatient hospital services rendered on April 4, 2018. The insurance carrier denied disputed services with claim adjustment reason code 29 "The time limit for filing has expired."
 - 28 TAC §133.20 (b) states in pertinent part,
 - (b) Except as provided in Labor Code §408.0272(b), (c) or (d), a health care provider shall not submit a medical bill later than the 95th day after the date the services are provided. In accordance with subsection (c) of the statute, the health care provider shall submit the medical bill to the correct workers' compensation insurance carrier not later than the 95th day after the date the health care provider is notified of the health care provider's erroneous submission of the medical bill. A health care provider who submits a medical bill to the correct workers' compensation insurance carrier shall include a copy of the original medical bill submitted, a copy of the explanation of benefits (EOB) if available, and sufficient documentation to support why one or more of the exceptions for untimely submission of a medical bill under §408.0272 should be applied.

Texas Labor Code 408.0272 (b) and (c) states in pertinent part,

- (b) Notwithstanding Section 408.0272, a health care provider who fails to timely submit a claim for payment to the insurance carrier under Section 408.0272(a) does not forfeit the provider's right to reimbursement for that claim for payment solely for failure to submit a timely claim if:
 - (1) the provider submits proof satisfactory to the commissioner that the provider, within the period prescribed by Section 408.0272(a), erroneously filed for reimbursement with:
 - (A) an insurer that issues a policy of group accident and health insurance under which the injured employee is a covered insured;
 - (B) a health maintenance organization that issues an evidence of coverage under which the injured employee is a covered enrollee; or
 - (C) a workers' compensation insurance carrier other than the insurance carrier liable for the payment of benefits under this title;
 - (2) the commissioner determines that the failure resulted from a catastrophic event that substantially interfered with the normal business operations of the provider.

The requestor states, "The Remittance from USAA was attached as proof of timely filing. We did not learn of Texas Mutual Insurance claim until 11/15/18."

Review of the mentioned USAA remittance indicates, "Personal Injury Protection" payment. This type of insurance is not listed in Texas Labor Code 408.0272. The Division found the information submitted does not support that an exception to Section 408.0272 applies.

The carrier's denial is supported. No additional payment is recommended.

Conclusion

For the reasons stated above, the Division finds that the requestor has not established that additional reimbursement is due. As a result, the amount ordered is \$0.00.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031, the division hereby determines the requestor is entitled to \$0.00 additional reimbursement for the services in dispute.
