#### RESPONDENT'S POSITION SUMMARY

Respondent's Position Summary: "This medical dispute concerns services provided by Memorial Hermann Hospital with date of service July 3, 2017. This request for medical dispute resolution is not timely. Under Division Rule 133.307(c)(1)(A), a Request for Medical Fee Dispute Resolution must be provided within one year of the date of service. Memorial Hermann Hospital requested medical dispute resolution for date of service July 3, 2017. It does not appear Memorial Hermann Hospital's medical fee dispute resolution request was made until February 19, 2019. Accordingly, the date of service at issue is outside of the one-year deadline and the Division lacks jurisdiction to consider this dispute."

#### FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

### **Background**

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
  - 1 Original DCN 35466741

- 2 This procedure on this date was previously reviewed
- 3 18 Duplicate claim/service
- 4 197 Precertification/authorization/notification absent

### <u>Issues</u>

1. Did the requestor waive the right to medical fee dispute resolution?

# **Findings**

1. 28 Texas Administrative Code §133.307(c)(1) states:

Timeliness. A requestor shall timely file the request with the division's MFDR Section or waive the right to MFDR. The division shall deem a request to be filed on the date the MFDR Section receives the request. A decision by the MFDR Section that a request was not timely filed is not a dismissal and may be appealed pursuant to subsection (g) of this section.

(A) A request for MFDR that does not involve issues identified in subparagraph (B) of this paragraph shall be filed no later than one year after the date(s) of service in dispute.

The date of the services in dispute is July 03, 2017. The request for medical fee dispute resolution was received in the Medical Fee Dispute Resolution (MFDR) Section on February 11, 2019. This date is later than one year after the date(s) of service in dispute. Review of the submitted documentation finds that the disputed services do not involve issues identified in §133.307(c)(1)(B). The Division concludes that the requestor has failed to timely file this dispute with the Division's MFDR Section; consequently, the requestor has waived the right to medical fee dispute resolution.

# **Conclusion**
