REQUESTOR'S POSITION SUMMARY

Requestor's Position Summary: "Phys conversion factor applied to Hospital Service. Physical therapy services have not been reimbursed per state fee schedule rules. PT service billed by a hospital on a UB are paid using the CMS calculation with the appropriate hospital uplift. Physician conversion factors are not applicable."

Amount in Dispute: \$41.05

FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 28 Texas Administrative Code §134.403 sets out the reimbursement guidelines for outpatient hospital services.
- 28 Texas Administrative Code §134.203 sets out the reimbursement guidelines for professional medical services.
- The insurance carrier reduced payment for the disputed services with the following claim adjustment

codes:

- P12 – Workers’ compensation jurisdictional fee schedule adjustment
- 119 – Benefit maximum for this time period or occurrence has been reached
- 163 – The charge for this procedure exceeds the unit value and/or the multiple procedure rules

Issues

1. Is the carrier’s reduction and denial of payment supported?
2. Is the requestor entitled to additional reimbursement?

Findings

1. The requestor is seeking additional reimbursement for outpatient therapy services performed from December 5 – 26, 2018. The insurance carrier limited the number of units based on “benefit maximum.”

Review of the submitted documentation found insufficient evidence to support the basis of the “benefit maximum.” This denial will not be considered in this review.

The reduction of the allowable based on the multiple procedure rules is applicable to 28 TAC §134.403 (d)

For coding, billing, reporting, and reimbursement of health care covered in this section, Texas workers' compensation system participants shall apply Medicare payment policies in effect on the date a service is provided

The application of the Medicare Multiple Procedure Payment Reduction (MPPR) may be found in the CMS Claims Processing Manual 100-04, Chapter 5, section 10.7 at www.cms.gov. The MPPR policy was used in the calculation of the maximum allowable reimbursement shown below.

2. 28 TAC §134.403 (f) and (h) determine the reimbursement of the remaining services in dispute and states,

(f) The reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually in the Federal Register.

(h) For medical services provided in an outpatient acute care hospital, but not addressed in the Medicare payment policies as outlined in subsections (f)(1) or (f)(2) of this section, and for which Medicare reimburses using other Medicare fee schedules, reimbursement shall be made using the applicable Division Fee Guideline in effect for that service on the date the service was provided.

The OPPS reimbursement formula factors are found at <https://www.cms.gov/Medicare/Medicare-Fee-for-Service-Payment/HospitalOutpatientPPS/Addendum-A-and-Addendum-B-Updates.html>. The specific factor is the Status Indicators. The status indicator for each of the HCPCS code listed on the DWC060 have an “A” status indicator which is defined as, “Not paid under OPPS. Paid by MACs under a fee schedule or payment system other than OPPS.”

Based on the requirements of 28 Texas Administrative Code §134.403 (h) the applicable Division fee guideline is found in 28 Texas Administrative Code §134.203 (c) (1) which states,

To determine the MAR for professional services, system participants shall apply the Medicare payment policies with minimal modifications.

(1) For service categories of Evaluation & Management, General Medicine, Physical Medicine and Rehabilitation, Radiology, Pathology, Anesthesia, and Surgery when performed in an office setting, the established conversion factor to be applied is (date of service yearly conversion factor).

The MAR is calculated by the DWC Conversion Factor of 58.31/Medicare Conversion Factor 35.9996 multiplied by the Medicare allowable. **To ensure the appropriate application of the MPPR reductions all services billed for each date will be calculated.** The calculation is as follows:

- Procedure code 97110 billed December 5, 2018 for two units has a PE of 0.4 the highest for this date. The first unit will be paid at the full allowable of \$31.55. The second unit will be paid at the

reduced rate of \$24.25. $58.31/35.996 \times \$31.55 = \51.10 . $58.31/35.9996 \times \$24.24 = \39.28 .
 $\$51.10 + \$39.28 = \$90.38$

- Procedure code 97110 billed December 11, 2018 for two units has a PE of 0.4 the highest for this date. The first unit will be paid at the full allowable of \$31.55. The second unit will be paid at the reduced rate of \$24.25. $58.31/35.996 \times \$31.55 = \51.10 . $58.31/35.9996 \times \$24.24 = \39.28 .
 $\$51.10 + \$39.28 = \$90.38$
- Procedure code 97110 billed December 12, 2018 for two units has a PE of 0.4 the highest for this date. The first unit will be paid at the full allowable of \$31.55. The second unit will be paid at the reduced rate of \$24.25. $58.31/35.996 \times \$31.55 = \51.10 . $58.31/35.9996 \times \$24.24 = \39.28 .
 $\$51.10 + \$39.28 = \$90.38$
- Procedure code 97110 billed December 17, 2018 for three units has a PE of 0.4 the highest for this date. The first unit will be paid at the full allowable of \$31.55. The second and third units will be paid at the reduced rate of \$24.25. $58.31/35.9996 \times \$31.55 = \51.10 . $58.31/35.996 \times \$24.24 \times 2 = \78.56 .
 $\$51.10 + \$78.56 = \$129.66$
- Procedure code 97110 billed December 18, 2018 for two units has a PE of 0.4 the highest for this date. The first unit will be paid at the full allowable of \$31.55. The second unit will be paid at the reduced rate of \$24.25. $58.31/35.996 \times \$31.55 = \51.10 . $58.31/35.9996 \times \$24.24 = \39.28 .
 $\$51.10 + \$39.28 = \$90.38$
- Procedure code 97110 billed December 26, 2018 for two units has a PE of 0.4 the highest for this date. The first unit will be paid at the full allowable of \$31.55. The second unit will be paid at the reduced rate of \$24.25. $58.31/35.996 \times \$31.55 = \51.10 . $58.31/35.9996 \times \$24.24 = \39.28 .
 $\$51.10 + \$39.28 = \$90.38$
- Procedure code 97140 billed December 5, 2018 has a PE of 0.35 not the highest for this date and will be paid at the reduced rate of \$22.33. $58.31/35.9996 \times \$22.33 = \36.17
- Procedure code 97140 billed December 11, 2018 has a PE of 0.35 not the highest for this date and will be paid at the reduced rate of \$22.33. $58.31/35.9996 \times \$22.33 = \36.17
- Procedure code G0283 billed December 12, 2018 has a PE of 0.23 not the highest for this date and will be paid at the reduced rate of \$11.03. $58.31/35.9996 \times \$11.03 = \17.87
- Procedure code G0283 billed December 18, 2018 has a PE of 0.23 not the highest for this date and will be paid at the reduced rate of \$11.03. $58.31/35.9996 \times \$11.03 = \17.87
- Procedure code G0283 billed December 26, 2018 has a PE of 0.23 not the highest for this date and will be paid at the reduced rate of \$11.03. $58.31/35.9996 \times \$11.03 = \17.87

The total allowable reimbursement for the services in dispute is \$707.51. The carrier paid \$707.51. No additional payment is recommended.

Conclusion

For the reasons stated above, the Division finds that the requestor has not established that additional reimbursement is due. As a result, the amount ordered is \$0.00.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031, the division hereby determines the requestor is entitled to \$0.00 additional reimbursement for the services in dispute.

YOUR RIGHT TO APPEAL

Either party to this medical fee dispute has a right to seek review of this decision in accordance with Rule §133.307, effective May 31, 2012, *37 Texas Register 3833*, **applicable to disputes filed on or after June 1, 2012.**

A party seeking review must submit a **Request to Schedule a Benefit Review Conference to Appeal a Medical Fee Dispute Decision** (form **DWC045M**) in accordance with the instructions on the form. The request must be received by the division within **twenty** days of your receipt of this decision. The request may be faxed, mailed or personally delivered to the division using the contact information listed on the form or to the field office handling the claim.

The party seeking review of the MFDR decision shall deliver a copy of the request to all other parties involved in the dispute at the same time the request is filed. **Please include a copy of the *Medical Fee Dispute Resolution Findings and Decision*** together with any other required information specified in 28 Texas Administrative Code §141.1(d).
