FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - 29 The time limit for filing has expired
 - 197 Precertification/authorization/notification absent
 - 193 Original payment decision is being maintained

<u>Issue</u>

1. Did the requestor waive the right to medical fee dispute resolution?

Findings

The requestor is seeking \$1,835.46 for outpatient hospital services rendered September 6, 2018.
28 TAC §133.307(c)(1) states a request for medical fee dispute resolution that does not involve compensability, extent of injury or liability, medical necessity or a refund shall be filed no later than one year after the date(s) of service in dispute.

The date of the service in dispute is September 6, 2018. The request for medical dispute resolution was received in the Medical Dispute Resolution (MDR) section on September 23, 2018.

This date is later than one year after the date(s) of service in dispute.

Review of the submitted documentation finds that the disputed services do not involve issues identified in §133.307, subparagraph (B).

DWC concludes that the requestor has failed to timely file this dispute with DWC's MDR Section; consequently, the requestor has waived the right to medical fee dispute resolution.

Conclusion

In resolving disputes over reimbursement for medically necessary health care to treat a compensable injury, the role of DWC is to adjudicate payment following Texas laws and DWC rules. The findings in this decision are based on the evidence available at the time of review. Even though not all the evidence was discussed, it was considered.

For the reasons above the requestor has not established payment is due. As a result, the amount ordered is \$0.00.

ORDER

Based upon the documentation submitted by the parties and in accordance with the provisions of Texas Labor Code §413.031, DWC has determined that the requestor is entitled to \$0.00 reimbursement for the disputed services.

A party seeking review must submit a **Request to Schedule a Benefit Review Conference to Appeal a Medical Fee Dispute Decision** (form **DWC045M**) in accordance with the instructions on the form. The request must be received by DWC within **twenty** days of your receipt of this decision. The request may be faxed, mailed or personally delivered to DWC using the contact information listed on the form or to the field office handling the claim.
