FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Background

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §134.503 sets out the fee guidelines for pharmaceutical services.

<u>Issues</u>

Is Memorial Compounding Pharmacy (Memorial) entitled to reimbursement for the drug in question?

Findings

Memorial is seeking reimbursement for drugs dispensed on July 22, 2019. In its position statement Flahive, Ogden & Latson argued on behalf of the insurance carrier, that the bill was paid.

The DWC finds that the evidence submitted does not support that a payment was made for the drug in question, therefore, Memorial is entitled to reimbursement.

- Meloxicam 15 mg tablets: (4.845 x 20 x 1.25) + \$4.00 = \$125.13
- Gabapentin 300 mg capsules: (1.3307 x 25 x 1.25) + \$4.00 = \$45.58
- Tramadol 50 mg tablets: (0.79615 x 25 x 1.25) + \$4.00 = \$28.88

The total allowable amount for the drug in question is \$199.59. This amount is recommended.

Conclusion

The outcome of this medical fee dispute relied upon the evidence presented by the requestor and the respondent at the time of adjudication. Though all the evidence may not have been discussed, it was considered. For the reasons stated above, the DWC finds that the requestor has established that additional reimbursement is due. As a result, the amount ordered is \$199.59.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031 and 413.019 (if applicable), the DWC has determined the requestor is entitled to additional reimbursement for the disputed services. The DWC hereby ORDERS the respondent to remit to the requestor \$199.59, plus applicable accrued interest per 28 Texas Administrative Code §134.130, due within 30 days of receipt of this order.
