FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Background

- 1. 28 Texas Administrative Code (TAC) §133.307, effective May 31, 2012 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.402, effective August 31, 2008, sets out the reimbursement guidelines for ambulatory surgical care (ASC) services.
- 3. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - P12-Workers' compensation jurisdictional fee schedule adjustment.
 - 983-Charge for this procedure exceeds Medicare ASC schedule allowance.

- 4123-Alloance is based on Texas ASC device intensive procedure calculation and guidelines.
- B13-Previously paid. Payment for this claim service may have been provided in a previous payment.
- W3-Additional payment made on appeal/reconsideration.
- 193-Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly.

<u>Issues</u>

Is the requestor entitled to additional reimbursement for ASC services rendered on October 22, 2019?

Findings

- 1. The requestor is seeking medical fee dispute resolution in the amount of \$1,205.04 for ASC services rendered to the injured worker on October 22, 2019.
- 2. The insurance carrier paid \$33,065.58 for the disputed services based upon the fee guideline.
- 3. The fee guidelines for disputed services is found in 28 TAC §134.402.
- 4. 28 TAC §134.402(b) (6) states,

Definitions for words and terms, when used in this section, shall have the following meanings, unless clearly indicated otherwise. "Medicare payment policy' means reimbursement methodologies, models, and values or weights including its coding, billing, and reporting payment policies as set forth in the Centers for Medicare and Medicaid Services (CMS) payment policies specific to Medicare.

The disputed services are defined as:

- 63685-Insertion or replacement of spinal neurostimulator pulse generator or receiver, direct or inductive coupling.
- 63650- Percutaneous implantation of neurostimulator electrode array, epidural.
- 5. 28 TAC §134.402(d) states,

For coding, billing, and reporting, of facility services covered in this rule, Texas workers' compensation system participants shall apply the Medicare payment policies in effect on the date a service is provided with any additions or exceptions specified in this section, including the following paragraphs.

Per ADDENDUM AA, CPT codes 63685 and 63650 are classified as device intensive procedures.

- 6. 28 TAC §134.402(b) defines "ASC device portion' means the portion of the ASC payment rate that represents the cost of the implantable device, and is calculated by applying the Centers for Medicare and Medicaid Services (CMS) Outpatient Prospective Payment System (OPPS) device offset percentage to the OPPS payment rate."
- 7. To determine if additional reimbursement is due the DWC refers to 28 TAC §134.402(f)(2)(A)(i)(ii) that states,

The reimbursement calculation used for establishing the MAR shall be the Medicare ASC reimbursement amount determined by applying the most recently adopted and effective Medicare Payment System Policies for Services Furnished in Ambulatory Surgical Centers and Outpatient Prospective Payment System reimbursement formula and factors as published annually in the Federal Register. Reimbursement shall be based on the fully implemented payment amount as in ADDENDUM AA, ASC COVERED SURGICAL PROCEDURES FOR CY 2008, published in the November 27, 2007 publication of the Federal Register, or its successor. The following minimal modifications apply: (2) Reimbursement for device intensive procedures shall be: (A) the sum of: (i) the ASC device portion; and (ii) the ASC service portion multiplied by 235 percent.

63685:

The following formula was used to calculate the MAR:

• Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 63685 for CY 2019 = \$27,697.85.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 63685 for CY 2019 is 82.90%

Multiply these two = \$22,961.52.

• Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare fully implemented ASC reimbursement rate for code 63685 for CY 2019 is \$22,581.16.

This number is divided by 2 = \$11,290.58.

This number multiplied by the City Wage Index for Plano, TX of 0.9862 = \$11,134.76.

The sum of these two is the geographically adjusted Medicare ASC reimbursement =\$22,425.34.

The service portion is found by taking the geographically adjusted rate of \$22,425.34 minus the device portion of \$22,961.52 = -\$536.18.

Multiply this number by the DWC payment adjustment of 235% = -\$1,260.02.

Step 3 the MAR is determined by adding the sum of the reimbursement for the device portion + the service portion = \$21,701.50. The insurance carrier paid \$20,632.10. As a result, the requestis due the difference between MAR and paid of \$1,069.40.

63650 (X2):

The following formula was used to calculate the MAR:

• Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 63650 for CY 2019 = \$5,979.53.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 63650 for CY 2019 is 50.80%

Multiply these two = \$3,037.60

• Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare fully implemented ASC reimbursement rate for code 63650 for CY 2019 is \$4,449.98.

This number is divided by 2 = \$2,224.99.

This number multiplied by the City Wage Index for Plano, TX of 0.9862 = \$2,194.28.

The sum of these two is the geographically adjusted Medicare ASC reimbursement =\$4,419.27.

The service portion is found by taking the geographically adjusted rate of 4,419.27 minus the device portion of 3,037.60 = 1,381.67.

Multiply this number by the DWC payment adjustment of 235% = \$3,246.92.

Step 3 the MAR is determined by adding the sum of the reimbursement for the device portion + the service portion = \$6,284.52/each X 2 = \$12,569.04. The insurance carrier paid \$6,216.74/each X 2 = \$12,433.48. As a result, the requestor is due the difference between MAR and paid of \$135.56.

8. The DWC finds the requestor is due additional reimbursement of \$1,204.96 for ASC services rendered on October 22, 2019.

Conclusion

For the reasons stated above, the DWC finds that the requestor has established that additional reimbursement is due. As a result, the amount ordered is \$1,204.96.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031 and 413.019 (if applicable), the DWC has determined the requestor is entitled to additional reimbursement for the disputed services. The DWC hereby ORDERS the respondent to remit to the requestor \$1,204.96, plus applicable accrued interest per 28 Texas Administrative Code §134.130 due within 30 days of receipt of this order.
