FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

Background

- 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 28 Texas Administrative Code §133.20 sets out requirements of medical bill submission.
- Texas Labor Code 408.0272 sets out the workers compensation timely billing and exceptions guidelines.
- The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
 - TO29 – The time limit for filing has expired

Issues

Are the insurance carrier’s reasons for denial of payment supported?

Findings

The requestor is seeking \$1,365.26 for outpatient hospital services rendered February 21, 2019. The insurance carrier denied disputed services based on untimely filing of claim.

28 TAC §133.20 (b) states in pertinent part unless an exception described in Texas Labor Code 408.0272 of an erroneous claim submission to a group accident and health insurance plan, a health maintenance organization or a workers’ compensation carrier other than the insurance carrier liable for the payment of benefits, a health care provider shall not submit a medical bill later than the 95th day after the date the services are provided.

The requestor indicated original claim was filed to medical insurance but the submitted documentation found insufficient evidence to support one of the exceptions found above. The insurance carrier’s denial is supported.

Conclusion

In resolving disputes over reimbursement for medically necessary health care to treat a compensable injury, the role of DWC is to adjudicate payment following Texas laws and DWC rules. The findings in this decision are based on the evidence available at the time of review. Even though not all the evidence was discussed, it was considered.

For the reasons above the requestor has not established payment is due. As a result, the amount ordered is \$0.00.

ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031, the division hereby determines the requestor is entitled to \$0.00 additional reimbursement for the services in dispute.

The request must be received by DWC within **twenty** days of your receipt of this decision. The request may be faxed, mailed or personally delivered to DWC using the contact information listed on the form or to the field office handling the claim.

The party seeking review of the MFDR decision shall deliver a copy of the request to all other parties involved in the dispute at the same time the request is filed. **Please include a copy of the *Medical Fee Dispute Resolution Findings and Decision*** together with any other required information specified in 28 TAC §141.1(d).
