# FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

#### **Background**

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §134.503 sets out the guidelines for pharmacy services.
- 3. 28 Texas Administrative Code 28 TAC §133.20 sets on requirements of medical bill submission.

#### Issues

Is the insurance carrier's position supported?

#### **Findings**

The requestor is seeking reimbursement of medication dispensed in June 2020. The insurance carrier states in their position statement the claim could not be processed as the National Drug Code (NDC) was invalid.

28 TAC §134.503 (b) states in pertinent part, for coding billing, reporting and reimbursement of prescription drugs and nonprescription drugs or over -the-counter medications Texas workers' compensation system participants shall apply the provisions of Chapters 133 and 134.

28 TAC §133.20 (c) states in pertinent part a health care provider shall include correct billing codes from the applicable Division fee guidelines in effect on the date(s) of service when submitting medical bills.

Review of the submitted NDC number found no records. The insurance carrier's position is supported.

No payment is recommended.

#### **Conclusion**

In resolving disputes over reimbursement for medically necessary health care to treat a compensable injury, the role of DWC is to adjudicate payment following Texas laws and DWC rules. The findings in this decision are based on the evidence available at the time of review. Even though not all the evidence was discussed, it was considered.

For the reasons above the requestor has not established payment is due. As a result, the amount ordered is \$0.00.

#### ORDER

Based on the submitted information, pursuant to Texas Labor Code Section 413.031, the division hereby determines the requestor is entitled to \$0.00 additional reimbursement for the services in dispute.

A party seeking review must submit a **Request to Schedule a Benefit Review Conference to Appeal a Medical Fee Dispute Decision** (form **DWC045M**) in accordance with the instructions on the form. The request must be received by DWC within **twenty** days of your receipt of this decision. The request may be faxed, mailed or personally delivered to DWC using the contact information listed on the form or to the field office handling the claim.

The party seeking review of the MFDR decision shall deliver a copy of the request to all other parties involved in the dispute at the same time the request is filed. **Please include a copy of the** *Medical Fee Dispute Resolution Findings and Decision* together with any other required information specified in 28 TAC §141.1(d).
