## FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

#### **Background**

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §134.403 sets out the reimbursement guidelines for outpatient hospital services.
- 3. The insurance carrier reduced or denied the payment for the disputed services with the following claim adjustment codes:
  - 97 Payment adjusted because the benefit for this service is included in the payment/allowance for another service/procedure that has already been adjudicated
  - P12 Workers' compensation jurisdictional fee schedule adjustment

#### Issues

- 1. What is the applicable rule for determining reimbursement for the disputed services?
- 2. Is the requestor entitled to additional reimbursement?

# **Findings**

- 1. The requestor is seeking additional reimbursement in the amount \$32.63 for outpatient hospital services rendered in November 2020. The insurance carrier reduced the disputed services based on workers' compensation fee schedule.
  - 28 TAC §134.403 (d) requires Texas workers' compensation system participants when coding, billing, reporting and reimbursement to apply Medicare payment policies in effect on the date of service.

The Medicare payment policy applicable to the services in dispute is found at <a href="www.cms.gov">www.cms.gov</a>, Claims processing Manual, Chapter 4, Section 10.1.1. Specifically, Payment Status Indicators and Ambulatory Payment Category (APC).

28 TAC 134.403 (f) states in pertinent part the reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually in the *Federal Register*.. The sum of the Medicare facility specific reimbursement amount and any applicable outlier payment amount shall be multiplied by 143 percent when a separate request for implant reimbursement is not made and 130 percent when separate reimbursement for implants is made.

The Medicare facility specific amount is calculated when the APC payment rate is multiplied by 60% to determine the labor portion. This amount is multiplied by the facility wage index for the date of service. The non-labor amount is determined when the APC payment rate is multiplied by 40%. The sum of the labor portion multiplied by the facility wage index and the non-labor portion determines the Medicare specific amount. Review of the submitted medical bill and the applicable fee guidelines referenced above is shown below.

• Procedure code 26910 has status indicator J1, for procedures paid at a comprehensive rate. This code is assigned APC 5113.

The OPPS Addendum A rate for the first quarter of FY 2021 is \$2,737.45. This is multiplied by 60% for an unadjusted labor amount of \$1,642.47, in turn multiplied by facility wage index 1.0011 (date of service is in first quarter of fiscal year 2021, wage index reflects 2021 wage index for provider) for an adjusted labor amount of \$1,644.28.

The non-labor portion is 40% of the APC rate, or \$1,094.98.

The sum of the labor and non-labor portions is \$2,739.26.

The Medicare facility specific amount is \$2,739.26. This is multiplied by 200% for a MAR of \$5,478.52.

2. The total recommended reimbursement for the disputed services is \$5,478.52. The insurance carrier paid \$5,446.00. The amount due is \$32.52. This amount is recommended.

# **Conclusion**

In resolving disputes over reimbursement for medically necessary health care to treat a compensable injury, the role of DWC is to adjudicate payment following Texas laws and DWC rules. The findings in this decision are based on the evidence available at the time of review. Even though not all the evidence was discussed, it was considered.

For the reasons above the requestor hast established payment is due. As a result, the amount ordered is \$32.52.

# **ORDER**

In accordance with Texas Labor Code Section 413.031 and 413.019 (if applicable) and based on the submitted information, DWC finds the requestor is entitled to additional reimbursement. DWC hereby ORDERS the respondent to remit to the requestor \$32.52, plus accrued interest per Rule §134.130, due within 30 days of receipt of this order.

The request must be received by DWC within **twenty** days of your receipt of this decision.
