#### FINDINGS AND DECISION

This medical fee dispute is decided pursuant to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation.

## **Background**

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 Texas Administrative Code §133.2 defines emergency.
- 3. The insurance carrier reduced payment for the disputed services with the following claim adjustment codes:
  - 16 Claim/service lacks information or has submission/billing error(s) which is needed for adjudication
  - 899 Documentation and file review does not support an emergency in accordance with Rule 133.2

#### <u>Issues</u>

Is the insurance carrier's denial of payment supported?

### **Findings**

The requestor is seeking reimbursement of outpatient emergency room services. The insurance carrier denied the disputed service as documentation does not support an emergency.

28 TAC §133.2 (5) states in pertinent part an emergency is a sudden onset of a medical condition with acute symptoms. Review of the medical record found "She is not in acute distress" with no mention of her pain level. The insurance carriers' denial is supported. No payment is recommended.

#### Conclusion

In resolving disputes over reimbursement for medically necessary health care to treat a compensable injury, the role of DWC is to adjudicate payment following Texas laws and DWC rules. The findings in this decision are based on the evidence available at the time of review. Even though not all the evidence was discussed, it was considered.

For the reasons above the requestor has not established payment is due. As a result, the amount ordered is \$0.00.

#### **ORDER**

Based on the submitted information, pursuant to Texas Labor Code Section 413.031, the division hereby determines the requestor is entitled to \$0.00 additional reimbursement for the services in dispute.
