### **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.503 sets out the fee guidelines for oral medications
- 3. 28 TAC §134.530 sets out the prior authorization requirements for oral medications.

#### **Denial Reasons**

Neither party submitted an explanation of payment or denial.

#### <u>Issues</u>

1. What rule(s) apply to disputed services?

### **Findings**

1. The requestor is seeking reimbursement for oral medication dispensed in April 2021. Insufficient evidence was found to support the insurance carrier processed these disputed services for payment or denial. The services in dispute will be reviewed per applicable fee quideline.

DWC Rule 28 Texas Administrative Code §134.503 (c) states the insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:

 Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;

DWC Rule 28 TAC §134.530 (b) (1) states preauthorization is required for drugs identified with a status of "N". The medication Tizanidine HCL was reviewed per ODG Appendix A for the date of service and found to have status "N". Insufficient evidence was found to support the requestor received prior authorization for this medication. Payment cannot be recommended.

The total reimbursement is \$205.33. This amount is recommended.

#### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$205.33 is due.

#### **Order**

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that Zurich American Insurance Co must remit to Memorial Compounding Pharmacy \$205.33 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
