Respondent's Position

The Austin carrier representative for Indemnity Insurance Co. of North America is Downs & Stanford, PC. The representative was notified of this medical fee dispute on August 17, 2021.

Per 28 Texas Administrative Code §133.307 (d)(1), if the DWC does not receive the response within 14 calendar days of the dispute notification, then the DWC may base its decision on the

available information.

As of today, no response has been received from the insurance carrier or its representative. We will base this decision on the information available.

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. 28 Texas Administrative Code §133.240 sets out the procedures for payment or denial of a medical bill.
- 2. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 3. 28 TAC §134.250 sets out the fee guidelines for examinations to determine maximum medical improvement and impairment rating.

Denial Reasons

Neither party submitted an explanation of benefits with reasons for the denial of payment for the disputed services.

Issues

- 1. Did Indemnity Insurance Co. of North America take final action on the bill for the disputed service before medical fee dispute resolution was requested?
- 2. Is John P. Hodges, Jr., D.C. entitled to reimbursement for the services in question?

Findings

- 1. Dr. Hodges is seeking reimbursement for a designated doctor examination to determine maximum medical improvement and impairment rating.
 - Dr. Hodges argued that he had not received payment or an explanation of denial for medical bills submitted for the examination in question.
 - According to 28 TAC §133.240 (a), the insurance carrier is required to take final action by paying, reducing, or denying the service in question not later than 45 days after receiving the medical bill. This deadline is not extended by a request for additional information.

The greater weight of evidence presented to DWC supports that a complete bill for the services in question was received by the insurance carrier or its agent. No evidence was provided to support that the insurance carrier took final action on the bill for the service in

question.

2. Because the insurance carrier failed to provide any defense of non-payment for the examination in question, Dr. Hodges is entitled to reimbursement.

The submitted documentation supports that Dr. Hodges performed an evaluation of maximum medical improvement as ordered by DWC. 28 TAC §134.250 (3)(C) states that the maximum allowable reimbursement (MAR) for this examination is \$350.00.

Review of the submitted documentation finds that Dr. Hodges performed impairment rating evaluations of the lumbar spine using the DRE method. The rule at 28 TAC §134.250 (4)(C) defines the fees for the calculation of an impairment rating. The MAR for the evaluation of a musculoskeletal body area determined using the DRE method is \$150.00.

The total allowable reimbursement for the services in question is \$500.00. This amount is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$500.00 is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that Indemnity Insurance Co. of North America must remit to John P. Hodges, Jr., D.C. \$500.00 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
