# **Requestor's Position**

"At this time we are requesting that this claim paid in accordance with the 2021 Texas Workers Compensation Fee Schedule and Guidelines for Ambulatory Surgical Centers."

Amount in Dispute: \$3,211.54

## **Respondent's Position**

"Audit is consistent with Rule 134.402-Ambulatory Surgical Center Fee Guideline. No additional payment."

## **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 TAC §133.307, sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.402, sets out the fee guidelines for ASC services.

#### **Denial Reasons**

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 763-Payment was allowed per the device intensive methodology. Reimbursement is 234% of service portion (\$4246.57 + \$2196.12) of Medicare's geographically adjusted fully implemented rate.
- 790-Payment for implants (\$2119.82 + \$1998.67) is being paid per Medicare device portion.
- CAC-P12-Workers' compensation jurisdictional fee schedule adjustment.
- 790-This charge was reimbursed in accordance to the Texas medical fee guideline.
- CAC-193-Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly.
- CAC-W3, 350-In accordance with TDI-DWC rule 134.804, this bill has been identified as a request for reconsideration or appeal.
- CAC-59-Processed based on multiple or concurrent procedure rules. (For example multiple surgery or diagnostic imaging, concurrent anesthesia).
- DC4-No additional reimbursement allowed after reconsideration.
- D25-Approved non-network provider for Workwell. TX Network claimant per rule 1305.153(C).
- 615-Payment for this service has been reduced according to Medicare multiple surgery guidelines.
- 763-Paid per ASC FG at 235%; implants not applicable or separate reimbursement (w/signed cert) not requested: Rule 134.402(G).

#### <u>Issues</u>

1. Is Metrocrest Surgery Center, LP entitled to additional reimbursement?

### <u>Findings</u>

1. The requestor is seeking medical fee dispute resolution in the amount of \$3,211.54 for ASC services rendered on June 7, 2021.

The respondent contends that additional reimbursement is not due because payment of \$10,561.18 was made per the fee guideline.

The fee guidelines for disputed services is found in 28 TAC §134.402.

A. Per Addendum AA, CPT codes 27829 is a device intensive procedure.

28 TAC §134.402(f)(2)(A)(i)(ii) states,

The reimbursement calculation used for establishing the MAR shall be the Medicare ASC reimbursement amount determined by applying the most recently adopted and effective Medicare Payment System Policies for Services Furnished in Ambulatory Surgical Centers Outpatient Prospective Payment System reimbursement formula and factors as published annually in the *Federal Register*. Reimbursement shall be based on the fully implemented payment amount as in ADDENDUM AA, ASC COVERED SURGICAL PROCEDURES FOR CY 2008, published in the November 27, 2007 publication of the *Federal Register*, or its successor. The following minimal modifications apply: (2) Reimbursement for device intensive procedures shall be: (A) the sum of: (i) the ASC device portion; and (ii) the ASC service portion multiplied by 235 percent."

The following formula was used to calculate the MAR:

Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 27829 for CY 2021 = \$6,264.95.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 27829 for CY 2021 is 33.37%.

Multiply these two = \$2,090.61.

Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare ASC reimbursement rate for code 27829 for CY 2021 is \$3,977.79.

This number is divided by 2 = \$1,988.90

This number multiplied by the City Wage Index for Carrollton, Texas of 0.9744 = \$1,937.98.

The sum of these two is the geographically adjusted Medicare ASC reimbursement =\$3,926.88

The service portion is found by taking the geographically adjusted rate minus the device portion = \$1,836.27.

Multiply the service portion by the DWC payment adjustment of 235% = \$4,315.24.

• Step 3 calculating the MAR:

The MAR is determined by adding the sum of the reimbursement for the device portion and the service portion = \$6,405.85.

The DWC finds the MAR for CPT code 27892 is \$6,405.85.

B. Per Addendum AA, CPT codes 27792 is a device intensive procedure.

The following formula was used to calculate the MAR:

• Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 27792 for CY 2021 = \$6,264.95.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 27792 for CY 2021 is 34.59%

Multiply these two = \$2,167.05.

• Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare ASC reimbursement rate for code 27792 for CY 2021 is \$3,917.86.

This number is divided by 2 = \$1,958.93.

This number multiplied by the City Wage Index for Carrollton, Texas of 0.9744 = \$1,908.78.

The sum of these two is the geographically adjusted Medicare ASC reimbursement =\$3,867.71.

The service portion is found by taking the geographically adjusted rate minus the device portion = \$1,700.66.

Multiply the service portion by the DWC payment adjustment of 235% = \$3,996.55.

• Step 3 calculating the MAR:

The MAR is determined by adding the sum of the reimbursement for the device portion and the service portion = \$6,163.60. This code is subject to multiple procedure discounting of 50%.

The DWC finds the MAR for CPT code 27792 is \$6,163.60 X 50% = \$3,081.80.

The DWC finds the MAR for the ASC services rendered on June 7, 2021 is \$9,487.65. The respondent paid \$10,561.18. The DWC finds the requestor is not due additional reimbursement.

#### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has not established that additional reimbursement is due.

#### **Order**

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is not entitled to additional reimbursement for the disputed services.

A party seeking review must submit DWC Form-045M, Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD) and follow the instructions on the form. DWC must receive the request within **20 days** of when you receive this decision.
