## **Requestor's Position**

"At this time we are requesting that this claim paid in accordance with the 2021 Texas Workers Compensation Fee Schedule and Guidelines for Ambulatory Surgical Centers."

Amount in Dispute: \$5,625.42

## **Respondent's Position**

"Review of the audit confirms that CPT code 27825 by the ASC facility has status indicator J8 which means the payment is made per Medicare device intensive method.

Reimbursement is 235% of service portion for CPT code 28725 ( $$3074.65 \times 2.35$ ) = \$7225.43, plus implants per device portion \$5308.30. Invoices for implants were not submitted on the initial audit or appeal, DWC60 packet does not provide invoice for implants.

Audit is consistent with Rule 13.402 – Ambulatory Surgical Center Fee Guideline. No additional payment."

## **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### **Statutes and Rules**

- 1. 28 TAC §133.307, sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.402, sets out the fee guidelines for ASC services.

### **Denial Reasons**

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- DC4, 790, 763 The payment was made per device intensive method correctly on first audit. Reimbursement is 235% of service portion (\$7225.43) of Medicare's Geographically Adjusted Fully Implemented Rate. Payment for implants (\$5308.30) is being paid per Medicare Device Portion. DC4, 923 Recoupment request will be sent for the overpayment of 27658 in the amount of \$1540.72. ASC Multiple Procedure Status was not applied on first audit.
- CAC-P12-Workers' compensation jurisdictional fee schedule adjustment.
- CAC-193-Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly.
- CAC-W3, 350-In accordance with TDI-DWC rule 134.804, this bill has been identified as a request for reconsideration or appeal.
- DC4-No additional reimbursement allowed after reconsideration.
- D25-Approved non-network provider for Workwell. TX Network claimant per rule 1305.153 (c).
- 763-Paid per ASC FG at 235%; implants not applicable or separate reimbursement (w/signed cert) not requested: Rule 134.402 (g).

#### <u>Issues</u>

1. Is Metrocrest Surgery Center entitled to additional reimbursement?

### **Findings**

1. The requestor is seeking medical fee dispute resolution in the amount of \$5,625.42 for ASC services rendered on May 20, 2021. Metrocrest Surgery Center did not request separate reimbursement for implantables.

The respondent contends that additional reimbursement is not due because payment of \$7,225.43 was made per the fee guideline.

The fee guidelines for disputed services are found in 28 TAC §134.402.

A. Per Addendum AA, CPT code 28725 is a device intensive procedure.

28 TAC §134.402(f)(2)(A)(i)(ii) states,

The reimbursement calculation used for establishing the MAR shall be the Medicare ASC reimbursement amount determined by applying the most recently adopted and effective Medicare Payment System Policies for Services Furnished in Ambulatory Surgical Centers and Outpatient Prospective Payment System reimbursement formula and factors as published annually in the *Federal Register*. Reimbursement shall be based on the fully implemented payment amount as in ADDENDUM AA, ASC COVERED SURGICAL PROCEDURES FOR CY 2008, published in the November 27, 2007 publication of the *Federal Register*, or its successor. The following minimal modifications apply: (2) Reimbursement for device intensive procedures shall be: (A) the sum of: (i) the ASC device portion; and (ii) the ASC service portion multiplied by 235 percent."

The following formula was used to calculate the MAR:

Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 28725 for CY 2021 = \$12,314.76.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 28725 for CY 2021 is 44.92%

Multiply these two = \$5,531.79.

• Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare ASC reimbursement rate for code 28725 for CY 2021 is \$8,491.64.

This number is divided by 2 = 44,245.82.

This number multiplied by the City Wage Index for Carrollton, Texas of 0.9744 = \$4137.13.

The sum of these two is the geographically adjusted Medicare ASC reimbursement = \$8,382.95.

The service portion is found by taking the geographically adjusted rate minus the device portion = \$2,851.16

Multiply the service portion by the DWC payment adjustment of 235% = \$6,700.22.

Step 3 calculating the MAR:

The MAR is determined by adding the sum of the reimbursement for the device portion and the service portion = \$12,232.00.

The DWC finds the MAR for CPT code 28725 is \$12,232.00

B. Per Addendum AA, CPT code 27658 is a non-device intensive procedure.

28 TAC §134.402(f)(1)(A) states,

The reimbursement calculation used for establishing the MAR shall be the Medicare ASC reimbursement amount determined by applying the most recently adopted and effective Medicare Payment System Policies for Services Furnished in Ambulatory Surgical Centers and Outpatient Prospective Payment System reimbursement formula and factors as published annually in the Federal Register. Reimbursement shall be based on the fully implemented payment amount as in ADDENDUM AA, ASC COVERED SURGICAL PROCEDURES FOR CY 2008, published in the November 27, 2007 publication of the Federal Register, or its successor. The following minimal modifications apply: (1) Reimbursement for non-device intensive procedures shall be: A) The Medicare ASC facility reimbursement amount multiplied by 235 percent.

• Step 1 calculating the geographically adjusted rate:

The Medicare ASC reimbursement for code 27658 CY 2021 is \$1,328.25.

The Medicare ASC reimbursement is divided by 2 = \$664.13.

This number multiplied by the City Wage Index for Carrollton, Texas of .9744= \$647.12.

Add these two together = \$1,311.25.

Step 2 calculating the MAR:

Multiply the geographically adjusted Medicare ASC reimbursement by the DWC payment adjustment factor of 235% = \$3,081.44

This code is subject to multiple procedure rule discounting of 50% = \$1,540.72.

The DWC finds the MAR for CPT code 27658 is \$1,540.72.

The DWC finds the total MAR for the ASC services rendered on May 20, 2021, is \$13,772.72. The respondent paid \$15,615.16. The DWC finds that no additional reimbursement is due.

### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has not established that additional reimbursement is due.

#### **Order**

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is not entitled to additional reimbursement for the disputed services.
