Requestor's Position

The requestor did not submit a position statement but did submit a copy of their reconsideration that states, "According to TWCC guidelines, Rule §134.403 states that the reimbursement calculation used for establishing the MAR shall be by using the Medical facility specific amount. After review the account we have concluded that reimbursement received was incorrect."

Amount in Dispute: \$2,604.03

Respondent's Position

The Carrier contends the Provider is not entitled to additional reimbursement.

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.403 sets out the fee guidelines for outpatient hospital services.

Denial Reasons

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 97 Payment adjusted because the benefit for this service is included in the payment/allowance for another service/procedure that has already been adjudicated
- P12 Workers' Compensation Jurisdictional fee schedule adjustment
- 96 Non-covered charge(s)

Issues

- 1. What rule applies for determining reimbursement for the disputed services?
- 2. Is the requester entitled to additional reimbursement?

<u>Findings</u>

- 1. The requestor is seeking additional reimbursement for services rendered in an outpatient hospital setting. DWC Rule 28 TAC §134.403 (d) requires Texas workers' compensation system participants when coding, billing, reporting and reimbursement to apply Medicare payment policies in effect on the date of service.
 - The Medicare payment policy applicable to the services in dispute is found at www.cms.gov, Claims processing Manual, Chapter 4, Section 10.1.1. Specifically, Payment Status Indicators and Ambulatory Payment Category (APC).
 - DWC Rule 28 TAC 134.403 (f) states in pertinent part the reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually in the *Federal Register*.

The Medicare facility specific amount is calculated when the APC payment rate is multiplied by 60% to determine the labor portion. This amount is multiplied by the facility wage index for the date of service. The non-labor amount is determined when the APC payment rate is

multiplied by 40%. The sum of the labor portion multiplied by the facility wage index and the non-labor portion determines the Medicare specific amount. Review of the submitted medical bill and the applicable fee guidelines referenced above is shown below.

 Procedure code 29879 has status indicator J1, for procedures paid at a comprehensive rate. All covered services on the bill are packaged with the primary "J1" procedure. This code is assigned APC 5113.

The OPPS Addendum A rate is \$2,830.40. This is multiplied by 60% for an unadjusted labor amount of \$1,698.24, in turn multiplied by facility wage index 0.8316 for an adjusted labor amount of \$1,412.26.

The non-labor portion is 40% of the APC rate, or \$1,132.16.

The sum of the labor and non-labor portions is \$2,544.42.

The Medicare facility specific amount is \$2,544.42 multiplied by 200% for a MAR of \$5,088.84.

- Procedure code 29880 also has a status indicator of J1. The Medicare Claims
 Processing Manual at www.cms.gov, states that when two procedure with J1 status are submitted on the medical claim the highest ranking code receives the only payment.
 Code 29880 has a ranking of 1,926. Code 29879 has a ranking of 1,789. Code 29879 receives the payment as shown above.
- 2. The total recommended reimbursement for the disputed services is \$5,088.84. The insurance carrier paid \$5,088.84. No additional payment is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has not established that additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is not entitled to additional reimbursement for the disputed services.
