Requestor's Position

The requestor did not submit a position statement but did submit a copy of their reconsideration that states, "Per the EOB the expected reimbursement was partially paid. The bill was paid according to the Separate reimbursement methodology but we billed requesting Global reimbursement."

Amount in Dispute: \$14,780.01

Respondent's Position

The Austin carrier representative for Utica Mutual Insurance Co is JT Parker & Associates. The representative was notified of this medical fee dispute on January 5, 2021.

Per 28 Texas Administrative Code §133.307(d)(1), if the DWC does not receive the response within 14 calendar days of the dispute notification, then the DWC may base its decision on the available information.

As of today, no response has been received from the insurance carrier or its representative. We

will base this decision on the information available.

Findings and Decision

Authority

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
2. 28 TAC §134.403 sets out the fee guidelines for outpatient hospital services.

Denial Reasons

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 193 – Original payment decision is being maintained. Upon review it was determined that this claim was processed properly
- 252 – An attachment / other documentation is required to adjudicate this claim/service
- P12 – Workers' compensation jurisdictional fee schedule adjustment

Issues

1. What rule applies for determining reimbursement for the disputed services?
2. Is the requester entitled to additional reimbursement?

Findings

1. The requestor is seeking additional reimbursement of outpatient hospital services. DWC Rule 28 TAC §134.403 (d) requires Texas workers' compensation system participants when coding, billing, reporting and reimbursement to apply Medicare payment policies in effect on the date of service.

The Medicare payment policy applicable to the services in dispute is found at www.cms.gov, Claims processing Manual, Chapter 4, Section 10.1.1. Specifically, Payment Status Indicators and Ambulatory Payment Category (APC).

28 TAC 134.403 (f) states in pertinent part the reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually

in the *Federal Register*.

The Medicare facility specific amount is calculated when the APC payment rate is multiplied by 60% to determine the labor portion. This amount is multiplied by the facility wage index for the date of service. The non-labor amount is determined when the APC payment rate is multiplied by 40%. The sum of the labor portion multiplied by the facility wage index and the non-labor portion determines the Medicare specific amount. This amount is multiplied by 200 per cent when the requestor has not made a request for separate reimbursement of implants.

Review of the submitted medical bill and the applicable fee guidelines referenced above is shown below.

- Procedure code 63685 has status indicator J1, for procedures paid at a comprehensive rate. This code is assigned APC 5465. The OPPS Addendum A rate is \$29,444.52 multiplied by 60% for an unadjusted labor amount of \$17,666.71, in turn multiplied by facility wage index 0.9579 for an adjusted labor amount of \$16,922.94.

The non-labor portion is 40% of the APC rate, or \$11,777.81.

The sum of the labor and non-labor portions is \$28,700.75.

The Medicare facility specific amount is \$28,700.75 multiplied by 200% for a MAR of \$57,401.50.

2. The total recommended reimbursement for the disputed services is \$57,401.50. The insurance carrier paid \$37,404.73. The requestor is seeking additional reimbursement of \$14,780.01. This amount is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requestor has established that additional reimbursement \$14,780.01 is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that Utica Mutual Insurance Co must remit to METSL LLC \$14,780.01 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
