Requestor's Position

This is a bill for services provided by Memorial Hermann Hospital for a workers comp injury for the above name patient. As of right now, inpatient bill has been underpaid.

Amount in Dispute: \$184,245.24

Respondent's Position

The carrier paid the bills per Texas Labor Code §413.011 and Texas Administrative Code Rule 134, et al. Requestor has offered no evidence o explanation as to why it is exempt from the Texas Labor Code or how the carrier's methodology did not follow the applicable rules.

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.404 sets out the acute care hospital fee guideline for inpatient services.

Denial Reasons

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- W3 Bill is a reconsideration or a appeal
- 193 Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly

<u>Issues</u>

- 1. What is the applicable rule for determining reimbursement for the disputed services?
- 2. Is the requestor entitled to additional payment?

Findings

1. This dispute regards inpatient hospital facility services with payment subject to 28 TAC §134.404(f), requiring the maximum allowable reimbursement (MAR) to be the Medicare facility specific amount (including outlier payments) applying Medicare Inpatient Prospective Payment System (IPPS) formulas and factors, as published annually in the Federal Register, with modifications set forth in the rules. Medicare IPPS formulas and factors are available from the Centers for Medicare and Medicaid Services at http://www.cms.gov.

The division calculates the Medicare facility specific amount using Medicare's *Inpatient PPS PC Pricer* as a tool to efficiently identify and apply IPPS formulas and factors. This software is freely available from www.cms.gov.

Note: the "VBP adjustment" listed in the *PC Pricer* was removed in calculating the facility amount for this admission. Medicare's Value-Based Purchasing (VBP) program is an initiative to improve quality of care in the Medicare system. However, such programs conflict with Texas Labor Code sections 413.0511 and 413.0512 regarding review and monitoring of health care quality in the Texas workers' compensation system. Rule §134.404(d)(1) requires that specific Labor Code provisions and division rules take precedence over conflicting CMS provisions for administering Medicare. Consequently, VBP adjustments are not considered in determining the facility reimbursement.

Separate reimbursement for implants was not requested. 28 TAC §134.404(f)(1)(A) requires that the Medicare facility specific amount be multiplied by 143%.

Review of the submitted medical bill and supporting documentation finds the NPI referenced on the medical bill is 1730132234. This NPI is associated with Medicare Provider number 450184.

- The assigned DRG code is 908.
- The service location is Houston, Texas.
- Based on DRG code, service location, and bill-specific information, the Medicare facility specific amount is \$21,395.05 multiplied by 143% results in a MAR of \$30,594.92.
- 2. The total recommended payment for the services in dispute is \$30,594.92. The insurance carrier paid \$18,678.83. An additional payment in the amount of \$11,916.09 is due to the requestor.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$11,916.09 is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that State National Insurance Co must remit to Memorial Hermann Hospital \$11,916.09 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
