



## Medical Fee Dispute Resolution Findings and Decision

## Findings and Decision

### Authority

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

### Statutes and Rules

1. 28 TAC §133.307, sets out the procedures for resolving medical fee disputes.
2. 28 TAC §134.402, sets out the fee guidelines for ASC services.

### Denial Reasons

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 193
- 1014
- 983-Charge for this procedure exceeds Medicare ASC schedule allowance.
- 4123-Allowance is based on Texas ASC device intensive procedure calculation and guidelines.
- P12-Workers' compensation jurisdictional fee schedule adjustment.
- 193-Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly.
- 1014-The attached billing has been re-evaluated at the request of the provider. Based on this re-evaluation, we find our original review to be correct. Therefore, no additional allowance appears to be warranted.

### Issues

1. Is Baylor Surgicare of Plano entitled to additional reimbursement?

### Findings

1. The requestor is seeking medical fee dispute resolution in the amount of \$19,643.97 for ASC services rendered on October 26, 2021.

The respondent contends that additional reimbursement is not due because payment of \$17,311.03 was made per the fee guideline.

The fee guidelines for disputed services is found in 28 TAC §134.402.

A. Per Addendum AA, CPT codes 62362 is a device intensive procedure.

28 TAC §134.402(f)(2)(A)(i)(ii) states,

The reimbursement calculation used for establishing the MAR shall be the Medicare ASC reimbursement amount determined by applying the most recently adopted and effective Medicare Payment System Policies for Services Furnished in Ambulatory Surgical Centers and Outpatient Prospective Payment System reimbursement formula and factors as published annually in the *Federal Register*. Reimbursement shall be based on the fully implemented payment amount as in ADDENDUM AA, ASC COVERED SURGICAL PROCEDURES FOR CY 2008, published in the November 27, 2007 publication of the *Federal Register*, or its successor. The following minimal modifications apply: (2) Reimbursement for device intensive procedures shall be: (A) the sum of: (i) the ASC device portion; and (ii) the ASC service portion multiplied by 235 percent."

The following formula was used to calculate the MAR:

- Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 62362 for CY 2021 = \$17,031.90.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 62362 for CY 2021 is 74.11%

Multiply these two = \$12,622.34.

- Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare ASC reimbursement rate for code 62362 for CY 2021 is \$14,162.85.

This number is divided by 2 = \$7,081.43.

This number multiplied by the City Wage Index for Plano, Texas of 0.9744 = \$6,900.14.

The sum of these two is the geographically adjusted Medicare ASC reimbursement = \$13,981.57.

The service portion is found by taking the geographically adjusted rate minus the device portion = \$1,359.23.

Multiply the service portion by the DWC payment adjustment of 235% = \$3,194.19.

- Step 3 calculating the MAR:

The MAR is determined by adding the sum of the reimbursement for the device portion and the service portion = \$15,816.53.

The DWC finds the MAR for CPT code 62362 is \$15,816.53. The respondent paid \$14,981.88. (The requestor noted on the DWC-60 amount paid was \$14,971.88. The EOB supports \$14,981.88) The difference between MAR and paid is \$834.65.

B. Per Addendum AA, CPT code 62350 is a device intensive procedure.

The following formula was used to calculate the MAR:

- Step 1 calculating the device portion of the procedure:

The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 62350 for CY 2021 = \$5,700.29.

The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 62350 for CY 2021 is 41.65%

Multiply these two = \$2,374.17.

- Step 2 calculating the service portion of the procedure:

Per Addendum AA, the Medicare ASC reimbursement rate for code 62350 for CY 2021 is \$3,533.15.

This number is divided by 2 = \$1,766.58.

This number multiplied by the City Wage Index for Plano, Texas of 0.9744 = \$1,721.35.

The sum of these two is the geographically adjusted Medicare ASC reimbursement = \$3,487.93.

The service portion is found by taking the geographically adjusted rate minus the device portion = \$1,113.76.

Multiply the service portion by the DWC payment adjustment of 235% = \$2,617.34.

- Step 3 calculating the MAR:

The MAR is determined by adding the sum of the reimbursement for the device portion and the service portion = \$4,991.50. This code is subject to multiple procedure rule discounting of 50% = \$2,495.75

The DWC finds the MAR for CPT code 62350 is \$2,495.75. The respondent paid \$2,329.15. The difference between MAR and amount paid is \$166.60.

The DWC finds the MAR for the ASC services rendered on March 25, 2021 is \$18,312.28. The respondent paid \$17,311.03. The DWC finds the requestor is due additional reimbursement of \$1,001.25.

### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requestor has established that additional reimbursement \$1,001.25 is due.

## Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that North River Insurance Co. must remit to Baylor Surgicare of Plano \$1,001.25 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

A party seeking review must submit DWC Form-045M, *Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD)* and follow the instructions on the form. DWC must receive the request within **20 days** of when you receive this decision.
