"After reviewing the explanation of benefits, it indicates that the carrier paid \$53.90 and not the full amount of \$116.30. This claim should be processed with the full amount billed as per Administrative Labor Code 134.503 (c)."

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.530 sets out the requirements for prior authorization of pharmacy services.
- 3. 28 TAC §134.503 sets out the fee guidelines for oral medications.

Denial Reasons

The insurance carrier denied the disputed services with the following claim adjustment codes:

- 193 Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly
- 197 Payment denied/reduced for absence of precertification/authorization
- P12 Workers' compensation jurisdictional fee schedule adjustment
- 4282 Drugs identified with a status of "Y" in the current edition of the "Official Disability Guidelines Treatment in Workers' Comp (ODG/Appendix A, "ODG Workers'

Issues

- 1. Is the insurance carrier's denial supported?
- 2. What rule(s) apply to disputed services?

Findings

- The requestor is seeking reimbursement for the oral medication Cyclobenzaprine for date of service November 11, 2021. The submitted explanation of benefits denies the claim for lack of preauthorization.
 - DWC Rule 28 Texas Administrative Code §134.530 (b) (1) states in pertinent part preauthorization is only required for drugs identified with a status of "N" in the current edition of the ODG Treatment in Workers Comp (ODG) / Appendix A, ODG Workers Compensation Drug Formulary, and any updates.
 - Review of the applicable Appendix A found the disputed drug is not indicated as a "N" drug. The insurance carrier's denial is not supported. The disputed service will be reviewed per applicable fee guideline.
- 2. DWC Rule 28 Texas Administrative Code §134.503 (c)(1)(A)(B) states in pertinent part (c) The

insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:

- (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
 - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;
 - (B) Brand name drugs: ((AWP per unit) x (number of units) x 1.09) + \$4.00 dispensing fee per prescription = reimbursement amount;

The total reimbursement is \$23.10. This amount is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that North River Insurance Co must remit to Memorial Compounding RX \$23.10 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
