Requestor's Position

The above claimant received medication as prescribed by referral provider. Bill for date of service 09/13/2021 was processed and paid incorrectly.

Amount in Dispute: \$283.73

Respondent's Position

The Austin carrier representative for New Hampshire Insurance Co is Flahive, Ogden & Latson. Flahive Ogden & Latson was notified of this medical fee dispute on April 05, 2022. Rule §133.307(d)(1) states that if the division does not receive the response within 14 calendar days of the dispute notification, then the division may base its decision on the available information. As of today, no response has been received from the carrier or its representative. We therefore base this decision on the information available as authorized under §133.307(d)(1).

Findings and Decision

Authority

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
2. 28 TAC §134.503 sets out the fee guidelines for pharmacy services.

Denial Reasons

The insurance carrier denied the payment for the disputed services with the following claim adjustment codes:

- 19 – Missing/invalid day supply

Issues

1. Is MEMORIAL COMPOUNDING RX entitled to additional reimbursement?

Findings

1. The requestor is seeking reimbursement for oral medications dispensed on September 13, 2021.

28 TAC §134.503 (c) states The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:

- (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:

(A) Generic drugs: $((\text{AWP per unit}) \times (\text{number of units}) \times 1.25) + \4.00 dispensing fee per prescription = reimbursement amount;

Reimbursement in the amount of \$282.79 is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$282.79 is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that NEW HAMPSHIRE INSURANCE CO must remit to MEMORIAL COMPOUNDING RX \$282.79 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

A party seeking review must submit DWC Form-045M, *Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD)* and follow the instructions on the form.
