Requestor's Position

"At this time we are requesting that this claim paid in accordance with the 2022 Texas Workers Compensation Fee Schedule and Guidelines for Ambulatory Surgical Centers."

Amount in Dispute: \$8,792.65

Respondent's Position

"The Carrier contends the Provider has been properly reimbursed for the disputed services in accordance with the Texas Workers' Compensation Act and adopted ambulatory surgical center fee schedule of the Division of Workers' Compensation."

Findings and Decision

Authority

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
2. 28 TAC 134.402 sets out the fee guidelines for ambulatory surgical centers.

Denial Reasons

The insurance carrier reduced/denied the payment for the disputed services with the following claim adjustment codes:

- P12 – Workers' compensation jurisdictional fee schedule adjustment
- 97 – Payment adjusted because the benefit for this service is included in the payment/allowance for another service/procedure that has already been adjudicated
- P14 – The benefit for this service is included in the payment/allowance for another service/procedure that has been performed on the same day

Issues

1. Is the insurance carriers' reduction supported?
2. Is the requester entitled to additional reimbursement?

Findings

1. The requestor is seeking additional reimbursement of a surgical procedure performed in an Ambulatory Surgical Center on January 6, 2022. The insurance carrier reduced the allowed amount based on workers' compensation fee schedule.

DWC Rule 28 TAC §134.402 (d) requires Texas workers' compensation system participants when coding, billing, reporting and reimbursement to apply Medicare payment policies in effect on the date of service.

The Medicare payment policy applicable to the services in dispute is found at www.cms.gov, Claims processing Manual, Chapter 4, Section 10.1.2 specifically Ambulatory Surgical Center Services on ASC list. Beginning with the implementation of the 2008 revised payment system, the labor related adjustments to the ASC payment rates are based on the Core-Based Statistical Area (CBSA) methodology. Payment rates for most services are geographically adjusted using the pre-reclassification wage index values that CMS uses to pay non-acute providers. The adjustment for geographic wage variation will be made based on a 50 percent labor related share.

DWC Rule 28 TAC §134.402 (f) states in pertinent part the reimbursement calculation used for establishing the MAR shall be the Medicare ASC reimbursement amount determined by applying the most recently adopted and effective Medicare Payment System Policies for Services Furnished in Ambulatory Surgical Centers and Outpatient Prospective Payment System reimbursement formula and factors as published annually in the Federal Register.

Reimbursement shall be based on the fully implemented payment amount published in the Federal Register. Reimbursement for device intensive procedures shall be the sum of the ASC device portion and the ASC service portion multiplied by 235 percent.

The following formula was used to calculate the MAR:

Review of the applicable Addendum AA, ASC covered surgical procedures Procedure Code 28730 has a payment indicator of J8. This is a device intensive procedure paid at an adjusted rate. The following formula was used to calculate the MAR:

Step 1 calculating the **device portion** of the procedure:

- The national reimbursement is found in the Addendum B for National Hospital Outpatient Prospective Payment System (OPPS) code 28730 for date of service is \$12,314.76.
- The device dependent APC offset percentage for National Hospital OPPS found in Addendum P for code 28730 for CY 2021 is 52.25%
- Multiply these two = $\$12,314.76 \times 52.25\% = \$6,434.46$

Step 2 calculating the **service portion** of the procedure:

- Per Addendum AA, the Medicare ASC reimbursement rate for code 28730 for date of service is \$9,227.51.
- This number is divided by 2 = $\$9,227.51 / 2 = \$4,613.75$.
- This number multiplied by the CBSA for Mansfield, Texas of 0.9744 = $\$4,613.75 \times 0.9744 = \$4,495.64$.
- The sum of these two is the geographically adjusted Medicare ASC reimbursement = $\$4,613.75 + 4,495.64 = \$9,109.39$.
- The service portion is found by taking the geographically adjusted rate minus the device portion = $\$9,109.39 - \$6,434.36 = \$2,675.03$
- Multiply the service portion by the DWC payment adjustment of 235% = $\$2,675.03 \times 235\% = \$6,286.32$.

Step 3 calculating the MAR:

- The MAR is determined by adding the sum of the reimbursement for the

device portion and the service portion = \$6,434.46 + \$6,286.32 = \$12,720.78.

- The DWC finds the MAR for CPT code 28730 is \$12,720.78. The respondent paid \$12,076.36. The remaining balance of \$644.42 is due to the requestor.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that Standard Fire Insurance must remit to Baylor Surgicare at Mansfield \$644.42 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

Your Right to Appeal

Either party to this medical fee dispute has a right to seek review of this decision under 28 TAC §133.307, which applies to disputes filed on or after **June 1, 2012**.

A party seeking review must submit DWC Form-045M, *Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD)* and follow the instructions on the form. You can find the form at www.tdi.texas.gov/forms/form20numeric.html. DWC must receive the request within **20 days** of when you receive this decision. You may fax, mail, or personally deliver your request to DWC using the contact information on the form or the field office handling the claim.
