Requestor's Position

The above claimant received Medication as prescribed by referral provider. Bill for date of service 03/21/2022 still has not been processed by carrier. All bills are required to be processed within 45 days of receipts by the carrier a per Texas Labor Code 408.027(b).

Amount in Dispute: \$88.42

Respondent's Position

No insurance carrier response received.

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. 28 Texas Administrative Code §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.503 sets out the pharmacy fee guideline.

Denial Reasons

The insurance carrier denied the payment for the disputed services with the following claim adjustment codes:

• No denial reason given on explanation of benefit

Issues

- 1. Did the insurance carrier respond to the DWC-60 in dispute?
- 2. Is MEMORIAL COMPOUNDING RX entitled to reimbursement?

<u>Findings</u>

- 1. The Austin carrier representative for ARCH Insurance Co is Flahive Ogden & Latson. Flahive Ogden & Latson was notified of this medical fee dispute on June 14, 2022. Rule §133.307(d)(1) states that if the division does not receive the response within 14 calendar days of the dispute notification, then the division may base its decision on the available information. As of today, no response has been received from the carrier or its representative. We therefore base this decision on the information available as authorized under §133.307(d)(1).
- 2. MEMORIAL COMPOUNDING RX is requesting reimbursement for Ibuprofen 600 mg dispensed on March 21, 2022.

DWC Rule 28 Texas Administrative Code §134.503(c)(1)(A) states

The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:

- (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
 - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;

The total reimbursement is \$19.32. This amount is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$19.32 is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that ARCH INSURANCE CO must remit to MEMORIAL COMPOUNDING RX \$19.32 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
