Requestor's Position

Respondent's Position

The Austin carrier representative for Arch Indemnity Insurance Co. is Flahive, Ogden & Latson. The representative was notified of this medical fee dispute on July 19, 2022.

Per 28 Texas Administrative Code §133.307 (d)(1), if the DWC does not receive the response within 14 calendar days of the dispute notification, then the DWC may base its decision on the available information.

As of today, no response has been received from the insurance carrier or its representative.

We will base this decision on the information available.

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. 28 Texas Administrative Code §133.20 sets out the procedures for submission of medical bills.
- 2. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.

Denial Reasons

Neither party submitted an explanation of benefits with reasons for non-payment of payment for the disputed services.

<u>lssues</u>

1. Is Richard Channing, D.C. entitled to additional reimbursement?

<u>Findings</u>

1. Dr. Channing is seeking reimbursement for a designated doctor examination to determine the extent of the compensable injury. 28 TAC §133.20 requires the health care provider to submit medical bills to the insurance carrier.

Per 28 TAC §133.307 (c)(2), all evidence to support its request for the fees in question. Review of the submitted documentation does not support that a medical bill for the services in question was submitted to the insurance carrier. No reimbursement can be recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has not established that additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is not entitled to additional reimbursement for the disputed services.
