# **Requestor's Position**

"As stated in my request for reconsideration, a FCE does not require pre-authorization or "approval by the handler" as defined by Rule 134.600 because this is an examination and not treatment. Second, I am the treating doctor for this particular patient."

# Amount in Dispute: \$503.34

# **Respondent's Position**

"The bill in question was denied on 6/28/22 under control number 218225469 as not authorized per adjuster's instructions: I didn't approve any FCE, UR didn't either do not pay. Below is what doesn't require pre-auth. FCE always require it."

# Response Submitted by: The Hartford

# <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

### Statutes and Rules

- 1. 28 Texas Administrative Code (TAC) §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.225, effective July 7, 2016, sets the reimbursement guidelines for FCEs.
- 3. 28 TAC §134.600, sets out the preauthorization guidelines for specific treatments and services.
- 4. 28 TAC §137.100, sets out the use of the treatment guidelines.
- 5. 28 TAC §134.203, sets out the fee guidelines for reimbursement of professional medical services.

#### Denial Reasons

The insurance carrier reduced or denied the payment for the disputed services with the following claim adjustment codes:

- 133 THE DISPOSITION OF THIS CLAIM/SERVICE IS PENDING FURTHER REVIEW.
- AUTH PAYMENT DENIED/REDUCED FOR ABSENCE OF, OR EXCEEDED, PRE-CERTIFICATION/AUTHORIZATION. PRE-AUTHORIZATION WAS NOT OBTAINED AND TREATMENT WAS RENDERED WITHOUT THE APPROVAL OF TREATING DOCTOR. IF YOU REQUIRE ADDITIONAL INFORMATION REGARDING THIS BILL DECISION, CONTACT THE CLAIM HANDLER.
- PPRJ PAID WITHOUT PREJUDICE.
- 96 NON-COVERED CHARGE(S).
- NABA REIMBURSEMENT IS BEING WITHHELD AS THE TREATING DOCTOR AND/OR SERVICES RENDERED WERE NOT APPROVED BASED UPON HANDLER REVIEW IF YOU REQUIRE ADDITIONAL INFORMATION REGARDING THIS BILL DECISION, CONTACT THE CLAIM HANDLER.

#### <u>lssues</u>

- 1. Is the Insurance Carrier's denial reason supported?
- 2. Does the Multiple Procedure Payment Reduction (MPPR) apply to FCE's?
- 3. Is the Requestor entitled to reimbursement for CPT Code 97750-FC?

# <u>Findings</u>

1. The requestor seeks reimbursement for CPT Code 97750-FC x 8, rendered on June 16, 2022. According to the explanation of benefits, the carrier denied payment for the disputed FCE based upon a lack of preauthorization.

To determine if the requestor is eligible for reimbursement the DWC refers to the following:

- 28 TAC §134.600(p)(12), requires preauthorization for "treatments and services that exceed or are not addressed by the commissioner's adopted treatment guidelines or protocols and are not contained in a treatment plan preauthorized by the insurance carrier. This requirement does not apply to drugs prescribed for claims under §§134.506, 134.530 or 134.540 of this title (relating to Pharmaceutical Benefits)."
- According to the <u>Fitness for Duty</u> Chapter of the Official Disability Guidelines (ODG), an FCE is a recommended treatment.
- 28 TAC §134.225 states, "The following applies to functional capacity evaluations (FCEs). A maximum of three FCEs for each compensable injury shall be billed and reimbursed. FCEs ordered by the division shall not count toward the three FCEs allowed for each compensable injury. FCEs shall be billed using CPT code 97750 with modifier "FC." FCEs shall be reimbursed in accordance with §134.203(c)(1) of this title. Reimbursement shall be for up to a maximum of four hours for the initial test or for a division ordered test; a maximum of two hours for an interim test; and a maximum of three hours for the discharge test unless it is the initial test. Documentation is required."

Review of the submitted documentation does not support that the requestor exceeded the number of test or the amount of time allowed per the fee guideline, the DWC finds the denial of payment for a lack of preauthorization is not supported. The requestor is therefore due reimbursement per 28 TAC §134.225 and §134.203.

2. 28 TAC §134.203(b)(1) states, "For coding, billing, reporting, and reimbursement of professional medical services, Texas workers' compensation system participants shall apply the following: (1) Medicare payment policies, including its coding; billing; correct coding initiatives (CCI) edits; modifiers; bonus payments for health professional shortage areas (HPSAs) and physician scarcity areas (PSAs); and other payment policies in effect on the date a service is provided with any additions or exceptions in the rules."

On the disputed dates of service, the requestor billed CPT code 97550-FC (X8). The multiple procedure rule discounting applies to the disputed service.

Medicare Claims Processing Manual Chapter 5, 10.7-effective June 6, 2016, titled Multiple Procedure Payment Reductions for Outpatient Rehabilitation Services, states:

Full payment is made for the unit or procedure with the highest PE payment. For subsequent units and procedures with dates of service prior to April 1, 2013, furnished to the same patient on the same day, full payment is made for work and malpractice and 80 percent payment is made for the PE for services submitted on professional claims (any claim submitted using the ASC X12 837 professional claim format or the CMS-1500 paper claim form) and 75 percent payment is made for the PE for services submitted on institutional claims (ASC X12 837 institutional claim format or Form CMS-1450).

For subsequent units and procedures with dates of service on or after April 1, 2013, furnished to the same patient on the same day, full payment is made for work and malpractice and 50 percent payment is made for the PE for services submitted on either professional or institutional claims.

To determine which services will receive the MPPR, contractors shall rank services according to the applicable PE relative value units (RVU) and price the service with the highest PE RVU at 100% and apply the appropriate MPPR to the remaining services. When the highest PE RVU applies to more than one of the identified services, contractors shall additionally sort and rank these services according to highest total fee schedule amount, and price the service with the highest total fee schedule amount at 100% and apply the appropriate MPPR to the remaining services.

4. 28 TAC §134.203 states in pertinent part, "(c) To determine the MAR for professional services, system participants shall apply the Medicare payment policies with minimal modifications. (1) For service categories of Evaluation & Management, General Medicine, Physical Medicine and Rehabilitation, Radiology, Pathology, Anesthesia, and Surgery when performed in an office setting, the established conversion factor to be applied is \$52.83. For Surgery when performed in a facility setting, the established conversion factor to be applied is \$66.32. (2) The conversion factors listed in paragraph (1) of this subsection shall be the conversion factors for calendar year 2008. Subsequent year's conversion factors shall be determined by applying the annual percentage adjustment of the Medicare Economic Index (MEI) to the previous year's conversion factors, and shall be effective January 1st of the new calendar year..."

To determine the MAR the following formula is used: (DWC Conversion Factor/Medicare Conversion Factor) X Medicare Payment = Maximum Allowable Reimbursement (MAR).

- MPPR rates are published by carrier and locality.
- The disputed date of service was rendered in 2022.
- The 2022 DWC Conversion Factor is 62.46.
- The 2022 Medicare Conversion Factor is 36.6062.
- Per the medical bills, the services were rendered in zip code 77581; therefore, the Medicare locality is "Brazoria."
- The Medicare participating amount for CPT code 97750 at this locality is \$34.86 for the first unit, and \$25.66 for subsequent units.
- Using the above formula, the DWC finds the MAR is \$62.92 for the first unit, and \$46.31 for subsequent units; \$62.92 + \$324.19 = MAR \$387.11.
- The respondent paid \$0.00.
- Reimbursement of \$387.11 is recommended.
- 3. The DWC finds that the requestor has established that reimbursement of \$387.11 is due As a result, this amount is recommended.

# **Conclusion**

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

The DWC finds the requester has established that reimbursement of \$387.11 is due.

# Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to reimbursement for the disputed services. It is ordered that the Respondent must remit to the Requestor \$387.11 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
