# Medical Fee Dispute Resolution Findings and Decision

## **Requestor's Position**

Bill for date of service **08/29/2022** was processed and paid **INCORRECTLY**.

**Amount in Dispute:** \$33.86

## **Respondent's Position**

The Austin carrier representative for American Casualty Co. of Reading PA is Continental Casualty Co. The representative was notified of this medical fee dispute on November 8, 2022.

Per 28 Texas Administrative Code §133.307 (d)(1), if the DWC does not receive the response within 14 calendar days of the dispute notification, then the DWC may base its decision on the available information.

As of today, no response has been received from the insurance carrier or its representative. We will base this decision on the information available.

### **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### **Statutes and Rules**

- 1. 28 Texas Administrative Code §133.240 sets out the procedures for payment or denial of a medical bill.
- 2. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 3. 28 TAC §134.503 sets out the fee guidelines for pharmaceutical services.

#### **Denial Reasons**

Neither party submitted an explanation of benefits with reasons for the denial of payment for the disputed services.

#### Issues

- 1. Did American Casualty Co. of Reading PA take final action on the bill for the disputed service before medical fee dispute resolution was requested?
- 2. Is Memorial Compounding Rx (Memorial) entitled to additional reimbursement?

## **Findings**

1. Memorial is seeking reimbursement for Tramadol HCl 50 mg Tablets dispensed on August 29, 2022.

Per 28 TAC §133.240 (a), the insurance carrier is required to take final action by paying, reducing, or denying the service in question not later than 45 days after receiving the medical bill. This deadline is not extended by a request for additional information.

The greater weight of evidence presented to DWC supports that a complete bill for the services in question was received by the insurance carrier or its agent. No evidence was provided to support that the insurance carrier took final action on the bill for the service in question.

 Because American Casualty Co. of Reading PA failed to provide any defense for its nonpayment for the service in this dispute, DWC finds that Memorial is entitled to reimbursement.

The reimbursement considered in this dispute is calculated according to 28 TAC §134.503 (c).

• Tramadol HCl 50 mg Tablets:  $(0.79615 \times 30 \times 1.25) + $4.00 = $33.86$ 

The total allowable reimbursement is \$33.86. This amount is recommended.

#### **Conclusion**

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$33.86 is due.

#### **Order**

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that American Casualty Co. of Reading PA must remit to Memorial Compounding Rx \$33.86 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

DWC must receive the request within **20 days** of when you receive this decision.
