### **Findings and Decision**

#### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.403 sets out the fee guidelines for outpatient hospital services.

#### **Denial Reasons**

The insurance carrier reduced or denied the payment for the disputed services with the following claim adjustment codes:

- 217 The value of this procedure is included in the value of another procedure performed on this date
- 370 This hospital outpatient allowance was calculated according to the APC rate plus a markup
- 616 This code has a status Q APC indicator and is packaged into other APC codes that have been identified by CMS
- 95 Plan procedures not followed
- 97 The benefit for this service is included in the payment/allowance for another service/procedure that has already been adjudicated
- P12 Workers' compensation jurisdictional fee schedule adjustment987

#### <u>Issues</u>

- 1. What rule applies for determining reimbursement for the disputed services?
- 2. Is the requester entitled to additional reimbursement?

### **Findings**

- 1. The requestor is seeking additional reimbursement for outpatient hospital services rendered in February 2022. The insurance reduced the disputed services based on bundling and workers compensation fee schedule.
  - DWC Rule 28 TAC §134.403 (d) requires Texas workers' compensation system participants when coding, billing, reporting and reimbursement to apply Medicare payment policies in effect on the date of service.

The Medicare payment policy applicable to the services in dispute is found at <a href="www.cms.gov">www.cms.gov</a>, Claims processing Manual, Chapter 4, Section 10.1.1. Specifically, Payment Status Indicators and Ambulatory Payment Category (APC).

DWC Rule 28 TAC 134.403 (e) states in pertinent part, regardless of billed amount, when no specific fee schedule or contract reimbursement shall be the maximum allowable reimbursement (MAR) amount under subsection (f) of this section including any applicable outlier payment amounts and reimbursement for implantables.

DWC Rule 28 TAC 134.403 (f) states in pertinent part the reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually in the *Federal Register*.

The Medicare facility specific amount is calculated when the APC payment rate is multiplied by 60% to determine the labor portion. This amount is multiplied by the facility wage index for the date of service. The non-labor amount is determined when the APC payment rate is multiplied by 40%. The sum of the labor portion multiplied by the facility wage index and the non-labor portion determines the Medicare specific amount. Review of the submitted medical bill and the applicable fee guidelines referenced above is shown below.

- Procedure code 73560 has status indicator Q1, for STV-packaged codes; reimbursement is packaged with payment for any service assigned status indicator S, T or V.
- Procedure code 99284 has status indicator J2 comprehensive procedure when outpatient visits of 8 or more hours observation is billed. As the criteria for comprehensive observation was not met. This code has a status indicator of V and APC 5024.

The OPPS Addendum A rate is \$371.52 multiplied by 60% for an unadjusted labor amount of \$222.91, in turn multiplied by facility wage index 0.841 for an adjusted labor amount of \$187.47.

The non-labor portion is 40% of the APC rate, or \$148.61.

The sum of the labor and non-labor portions is \$336.08.

The Medicare facility specific amount is \$336.08 multiplied by 200% for a MAR of \$672.16.

Procedure code 96374 has status indicator S, separate APC payment. APC 5693. The OPPS Addendum A rate is \$208.93 multiplied by 60% for an unadjusted labor amount of \$125.36, in turn multiplied by facility wage index 0.841 for an adjusted labor amount of \$105.43.

The non-labor portion is 40% of the APC rate, or \$83.57.

The sum of the labor and non-labor portions is \$189.00.

The Medicare facility specific amount is \$189.00 multiplied by 200% for a MAR of \$378.00.

• Procedure code 96375 has status indicator S, separate APC payment. APC 5691. The OPPS Addendum A rate is \$40.87 multiplied by 60% for an unadjusted labor amount of \$24.52, in turn multiplied by facility wage index 0.841 for an adjusted labor amount of \$20.62.

The non-labor portion is 40% of the APC rate, or \$16.35.

The sum of the labor and non-labor portions is \$36.97.

The Medicare facility specific amount is \$36.97 multiplied by 200% for a MAR of \$73.94.

- Procedure code J2405 has status indicator N, reimbursement is included with payment for the primary services.
- Procedure code J1885 has status indicator N, reimbursement is included with payment for the primary services.
- 2. The total recommended reimbursement for the disputed services is \$1,124.10. The insurance carrier paid \$672.15. The requestor is seeking additional reimbursement of \$447.98. This amount is recommended.

#### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement of \$447.98 is due.

#### **Order**

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that TASB Risk Management Fund must remit to Texas Vista Medical Center \$447.98 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

DWC must receive the request within **20 days** of when you receive this decision.
