# **Requestor's Position**

"He is in treatment with testosterone every 2 weeks.... Patient also has important musculo skeletal problems including LBP causing numbness and tingling in legs... Patient also has... apparently secondary to his medical problems and injuries from a work's accident. He has been requiring multiple medical office visits and treatment."

Amount in Dispute: \$1,400.00

## **Respondent's Position**

"ACIG denied the request for reimbursement because it was not submitted timely. As required under Division Rule 133.20, a health care provider shall submit all medical bills to the insurance carrier no later than the 95th day after the date of service is provided. The 95th day after the June 7, 2022 office visit was September 10, 2022 yet the bill was not received by ACIG until November 1, 2022. In the DWC-62 Explanation of Benefits, the text to explain the reason for denial noted the time limit for filing has expired."

## **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 Texas Administrative Code (TAC) §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §133.20 sets out the medical bill submission procedures for health care providers.
- 3. 28 TAC §102.4 sets out the rules for non-Commission communications.
- 4. TLC §408.027 sets out the rules for timely submission of claims by health care providers.
- 5. TLC §408.0272 provides for certain exceptions to untimely submission of a medical bill.

## **Denial Reasons**

The insurance carrier reduced or denied the payment for the disputed services with the following claim adjustment codes:

T025 – The time limit for filing has expired.

#### <u>Issues</u>

- 1. What is the timely filing deadline applicable to the medical bills for the services in dispute?
- 2. Did the requestor forfeit the right to reimbursement for the services in dispute?

## **Findings**

The insurance carrier denied the disputed services due to "The time limit for filing has expired."

28 TAC §133.20(b) requires that, except as provided in TLC §408.0272, "a health care provider shall not submit a medical bill later than the 95th day after the date the services are provided."

The requestor submitted insufficient documentation to support that any of the exceptions described in TLC §408.0272 apply to the services in this dispute. For that reason, the requestor in this dispute was required to submit the medical bill not-later than 95 days after the date the disputed services were provided.

TLC §408.027(a) states, in pertinent part, that "Failure by the health care provider to timely submit a claim for payment constitutes a forfeiture of the provider's right to reimbursement for that claim for payment."

28 TAC §102.4(h) states that "Unless the great weight of evidence indicates otherwise, written communications shall be deemed to have been sent on: (1) the date received, if sent by fax, personal delivery, or electronic transmission or, (2) the date postmarked if sent by mail via United States Postal Service regular mail, or, if the postmark date is unavailable, the later of the signature date on the written communication or the date it was received minus five days. If the date received minus five days is a Sunday or legal holiday, the date deemed sent shall be the next previous day which is not a Sunday or legal holiday."

Review of the submitted information finds no documentation to support that a medical bill was submitted within 95 days from the date the services were provided. Therefore, pursuant to TLC §408.027(a), the requestor has forfeited the right to reimbursement due to untimely submission of the medical bill for the disputed services.

#### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

The DWC finds the requester has established that no reimbursement is due.

### Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is not entitled to reimbursement for the disputed services.
