## **Requestor's Position**

## **Respondent's Position**

The Austin carrier representative for Old Republic Insurance Co is White Espey. The representative was notified of this medical fee dispute on December 13, 2022.

## **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.530 sets out the requirements of prior authorization.
- 3. 28 TAC §134.503 sets out the fee guidelines for pharmacy services.

#### **Denial Reasons**

• HE75 – Prior Authorization required to process this bill.

#### <u>Issues</u>

1. What rule(s) apply to disputed services?

### **Findings**

- 1. The requestor is seeking reimbursement for oral medication dispensed in August 2022. The insurance company denied the service for lack of pre-authorization.
  - DWC Rule 134.530 (b)(1)(A) states in pertinent parts preauthorization is only required for drugs identified with a status of "N" in the current edition of the ODG Treatment in Workers Comp (ODG) / Appendix A, ODG Workers' Compensation Drug Formulary;.
  - Review of the applicable ODG Appendix A listing for the topical analgesic "Bio-Freeze" found the status to be "Y". The insurance carrier's denial is not supported. The disputed service will be reviewed per applicable fee guideline.
- 2. DWC Rule 28 Texas Administrative Code §134.503 (c)(1)(A)(B) states in pertinent part (c) The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:
  - (1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:
    - (A) Generic drugs: ((AWP per unit) x (number of units) x 1.25) + \$4.00 dispensing fee per prescription = reimbursement amount;
    - (B) Brand name drugs: ((AWP per unit) x (number of units) x 1.09) + \$4.00 dispensing fee per prescription = reimbursement amount;

The total reimbursement is \$17.06. This amount is recommended.

#### Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement is due.

#### Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor entitled to additional reimbursement for the disputed services. It is ordered that Old Republic Insurance Co must remit to Memorial Compounding RX \$17.06 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.
