



## Medical Fee Dispute Resolution Findings and Decision

### Requestor's Position

"After reviewing the explanation of benefits, it appears that carrier paid \$266.13 and not the full amount of \$441.40. This claim should be processed with the full amount billed as per Administrative Labor Code 134.503(c)."

**Amount in Dispute:** \$174.20

### Respondent's Position

The Austin carrier representative for National Union Fire Insurance is Flahive, Ogden and Latson. The representative was notified of this medical fee dispute on December 20, 2022.

Per 28 Texas Administrative Code §133.307(d)(1), if the DWC does not receive the response within 14 calendar days of the dispute notification, then the DWC may base its decision on the available

information.

As of today, no response has been received from the insurance carrier or its representative. We will base this decision on the information available.

## Findings and Decision

### Authority

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

### Statutes and Rules

1. 28 TAC §133.307 sets out the procedures for resolving medical fee disputes.
2. 28 TAC §134.503 sets out the fee guidelines for pharmacy services.

### Denial Reasons

- Neither party submitted an explanation of benefits for the services in dispute.

### Issues

1. What rule(s) apply to disputed services?

### **Findings**

1. The requestor is seeking reimbursement for oral medication dispensed in October 2022. The insurance company provided insufficient evidence to support adjudication of this claim.

DWC Rule 28 Texas Administrative Code §134.503 (c)(1)(A)(B) states in pertinent part (c) The insurance carrier shall reimburse the health care provider or pharmacy processing agent for prescription drugs the lesser of:

(1) the fee established by the following formulas based on the average wholesale price (AWP) as reported by a nationally recognized pharmaceutical price guide or other publication of pharmaceutical pricing data in effect on the day the prescription drug is dispensed:

(A) Generic drugs:  $((\text{AWP per unit}) \times (\text{number of units}) \times 1.25) + \$4.00$  dispensing fee per prescription = reimbursement amount;

(B) Brand name drugs:  $((\text{AWP per unit}) \times (\text{number of units}) \times 1.09) + \$4.00$  dispensing fee per prescription = reimbursement amount;

The total reimbursement is \$149.88. This amount is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement is due.

**Order**

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that National Union Fire Insurance Co must remit to Memorial Compounding Pharmacy \$149.88 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

DWC must receive the request within **20 days** of when you receive this decision.
