"...The fee schedule allows for \$502.08 to be charged for PHYSICAL PERFORMANCE EVALUATION that lasts 2 hours (8 units)... The charge does not exceed the fee schedule... Therefore, this claim should be paid in full... "

Respondent's Position

"The bill related to the above captioned MDR was received on 09/26/2022 and paid on 02/21/2023 in the amount of \$339.34. Copies of the EOR and payment screens for the bill and interest payments issued are attached."

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to <u>Texas Labor Code §413.031</u> and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. <u>28 TAC §133.307</u> sets out the procedures for resolving medical fee disputes.
- 2. <u>28 TAC §134.203</u> sets out the fee guidelines for reimbursement of professional medical services provided in the Texas workers' compensation system.

Adjustment Reasons

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 240 Charge reviewed to multiple procedure ground rules.
- 362 Modifier GP Services delivered under an outpatient physical therapy plan of care.
- P12 Workers' Compensation jurisdictional fee schedule adjustment.
- ETBR A technical bill review has been performed.

<u>lssues</u>

- 1. Is the Insurance Carrier's (IC) reimbursement reduction reason supported?
- 2. Is the Requestor entitled to additional reimbursement for CPT Code 97750-GP?

<u>Findings</u>

1. The requestor seeks additional reimbursement for CPT Code 97750-GP rendered on September 20,2022. The insurance carrier reduced the disputed service with reduction code 240 (description indicated above.) The fee guidelines for disputed service 97750-GP are found at 28 TAC §134.203.

28 TAC §134.203(b)(1) states, "For coding, billing, reporting, and reimbursement of professional medical services, Texas workers' compensation system participants shall apply the following: (1) Medicare payment policies, including its coding; billing; correct coding initiatives (CCI) edits; modifiers; bonus payments for health professional shortage areas (HPSAs) and physician scarcity areas (PSAs); and other payment policies in effect on the date a service is provided with any additions or exceptions in the rules."

28 TAC §134.203 (c)(1) states, "To determine the maximum allowable reimbursement (MAR) for professional services, system participants shall apply the Medicare payment policies with minimal modifications. (1) For service categories of Evaluation & Management, General Medicine, Physical Medicine and Rehabilitation, Radiology, Pathology, Anesthesia, and Surgery when performed in an office setting, the established conversion factor to be applied is \$52.83..."

<u>Medicare Claims Processing Manual</u> Chapter 5, 10.3.7-effective June 6, 2016, titled Multiple Procedure Payment Reductions for Outpatient Rehabilitation Services, states:

Full payment is made for the unit or procedure with the highest PE payment. For subsequent units and procedures with dates of service prior to April 1, 2013, furnished to the same patient on the same day, full payment is made for work and malpractice and 80 percent payment is made for the PE for services submitted on professional claims (any claim submitted using the ASC X12 837 professional claim format or the CMS-1500 paper claim form) and 75 percent payment is made for the PE for services submitted on institutional claims (ASC X12 837 institutional

claim format or Form CMS-1450).

For subsequent units and procedures with dates of service on or after April 1, 2013, furnished to the same patient on the same day, full payment is made for work and malpractice and 50 percent payment is made for the PE for services submitted on either professional or institutional claims.

To determine which services will receive the MPPR, contractors shall rank services according to the applicable PE relative value units (RVU) and price the service with the highest PE RVU at 100% and apply the appropriate MPPR to the remaining services. When the highest PE RVU applies to more than one of the identified services, contractors shall additionally sort and rank these services according to highest total fee schedule amount, and price the service with the highest total fee schedule amount at 100% and apply the appropriate MPPR to the remaining services.

The division finds that the respondent's reimbursement reduction reason, based on multiple procedure ground rules, is supported.

2. On the disputed date of service, the requestor billed CPT code 97550-GP (x7).

CPT Code 97750-GP is defined as "Physical performance test or measurement (eg, musculoskeletal, functional capacity), with written report, each 15 minutes."

The requestor appended the "GP" modifier to code 97750. The "GP" modifier is described as "Services delivered under an outpatient physical therapy plan of care."

Per CMS' <u>Billing and Coding: Outpatient Physical and Occupational Therapy Services</u>, Article ID A56566, effective October 1, 2020:

These tests and measurements are beyond the usual evaluation services performed. Examples of physical performance tests or measurements include isokinetic testing, Functional Capacity Evaluation (FCE) and Tinetti. This code may be used for the 6-minute walk test, with a computerized report of the patient's oxygen saturation levels with increasing stress levels, performed under a PT or OT plan of care on pulmonary rehabilitation patients.

The therapy evaluation and re-evaluation codes are for a comprehensive review of the patient including, but not limited to, history, systems review, current clinical findings, establishment of a therapy diagnosis, and estimation of the prognosis and determination and/or revision of further treatment. CPT 97750 is intended to focus on patient performance of a specific activity or group of activities (CPT Assistant, December 2003).

There must be written evidence documenting the problem requiring the test, the specific test performed, and a separate measurement report. This report may include torque curves and other graphic reports with interpretation.

97750 should not be used to bill for patient assessments/re-assessments such as ROM testing or manual muscle testing completed at the start of care (as this is

typically part of the examination included in the initial evaluation) and/or as the patient progresses through the episode of treatment.

CPT code 97750 is not covered on the same day as CPT codes 97161-97168 (due to CCI edits).

Supportive Documentation Requirements (required at least every 10 visits) for 97750

- Problem requiring the test and the specific test performed
- Separate measurement report, including any graphic reports
- Application to functional activity
- How the test impacts the plan of care

Review of submitted medical documentation finds that the healthcare provider's documentation is in compliance with requirements outlined above.

The requester is seeking additional reimbursement for 7 units of CPT code 97750-GP rendered on September 20, 2022.

As demonstrated in finding #1 above, the multiple procedure rule (MPPR) discounting applies to the disputed service.

The MPPR Rate File that contains the payments for 2022 services is found at: www.cms.gov/Medicare/Billing/TherapyServices/index.html.

- The date of service is September 20, 2022.
- The DWC conversion factor for 2022 is 62.46.
- The Medicare conversion factor for 2022 is 34.6062.
- MPPR rates are published by carrier and locality.
- Review of Box 32 on the CMS-1500 medical bill finds that the services were rendered in zip code 75043; therefore, the Medicare locality is 11, Dallas, TX.
- The Medicare participating amount for CPT code 97750 in 2022, at this locality, is \$34.77 for the first unit, and \$25.54 for subsequent units.

To determine the MAR the following formula is used: (DWC Conversion Factor/Medicare Conversion Factor) X Medicare Payment = MAR.

Using the above formula, the MAR is \$62.76 for the first unit, and \$46.10 for subsequent units x 6 units = \$276.58.

Therefore, total MAR for 7 units of 97750 on September 20, 2022, = \$339.34.

The respondent paid \$339.34 plus \$6.71 interest owed for delayed payment.

The division finds that the requestor is not entitled to additional reimbursement.

<u>Conclusion</u>

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered. The DWC finds the requester has not established that additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to \$0.00 additional reimbursement for the disputed services.
