### **Requestor's Position**

"Our records indicate the claim was filed timely. Attached is documentation to establish the initial date of filing. Your lack of receipt may be due to a change of address, electronic transmission failure or other internal issues. However, it is our position that we have met our timely filing obligation."

#### Amount in Dispute: \$40,200.00

### **Respondent's Position**

"The Requestor provided a printout showing 'Date of Claim' in the dispute request as proof of timely filing seemingly indicating that the paper medical bill was originally submitted on this date... In fact, CorVel has no record of receipt of a complete medical bill pursuant to 28 TAC Chapter 133 for the date(s) of service in question until after the 95-day deadline. CorVel maintains the Requestor, Neurorestorative is not entitled to reimbursement for dates of service 06/01/2022 – 06/30/2022 in the amount of \$40,200.00 based on failure to timely submit a complete medical bill in accordance with health care provider billing rules set forth under 28 TAC Chapter 133 General Medical Provisions. In addition to failure to provide valid proof of timely filing in accordance with division rules."

### **Findings and Decision**

### <u>Authority</u>

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 Texas Administrative Code (TAC) §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §133.20 sets out the medical bill submission procedures for health care providers.
- 3. 28 TAC §102.4 sets out the rules for non-Commission communications.
- 4. TLC §408.027 sets out the rules for timely submission of claims by health care providers.
- 5. TLC §408.0272 provides for certain exceptions to untimely submission of a medical bill.

#### Denial Reasons

The insurance carrier reduced or denied the payment for the disputed services with the following claim adjustment codes:

- 29 Time limit for filing claim/bill has expired.
- Note: Effective 9/1/05, providers have 95 days to submit bills to the insurance carrier for reimbursement. Your bill exceeds this limit. Reimbursement is denied in accordance with Section 408.027 of the Act.
- RM2 Time limit for filing claim has expired.

#### <u>lssues</u>

- 1. What is the timely filing deadline applicable to the medical bills for the services in dispute?
- 2. Did the requestor forfeit the right to reimbursement for the services in dispute?

#### <u>Findings</u>

1. 28 TAC §133.20(b) requires that, except as provided in TLC §408.0272, "a health care provider shall not submit a medical bill later than the 95th day after the date the services are provided."

The DWC finds insufficient documentation to support that any of the exceptions described in TLC §408.0272 apply to the services in this dispute. For that reason, the requestor in this dispute was required to submit the medical bill not-later than 95 days after the date the disputed services were provided.

TLC §408.027(a) states, in pertinent part, that "Failure by the health care provider to timely submit a claim for payment constitutes a forfeiture of the provider's right to reimbursement for that claim for payment."

28 TAC §102.4(h) states that "Unless the great weight of evidence indicates otherwise, written communications shall be deemed to have been sent on: (1) the date received, if sent by fax, personal delivery, or electronic transmission or, (2) the date postmarked if sent by mail via United States Postal Service regular mail, or, if the postmark date is unavailable, the later of the signature date on the written communication or the date it was received minus five days. If the date received minus five days is a Sunday or legal holiday, the date deemed sent shall be the next previous day which is not a Sunday or legal holiday."

2. Review of the submitted information finds insufficient documentation to support that a medical bill was submitted within 95 days of the date the services were provided. Therefore, pursuant to TLC §408.027(a), the requestor has forfeited the right to reimbursement due to untimely submission of the medical bill for the disputed services.

#### **Conclusion**

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

The DWC finds the requester has established that reimbursement of \$0.00 is due.

#### Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to \$0.00 reimbursement for the disputed services

A party seeking review must submit DWC Form-045M, *Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD)* and follow the instructions on the form.
